: Direct Recruitment (from candidates belonging to LC/AI Community only)

Note:-

- 1) Applications submitted by candidates other than the community mentioned above will be rejected. No individual rejection memo will be issued.
- G.O.(P)No.01/2015/SJD dated.05.01.2015 2) As per differently abled candidates with Locomotor disability/Cerebral Palsy are identified as suitable for appointment to this post. Hence differently abled Blindness/Low candidates with Vision, Hearing Impairment are not eligible to apply for this post.
- **6.** Age limit :

23-39: (Only candidates born between 02/01/1981 and 01/01/1997 (both dates included) including relaxation in para 2(i) are eligible to apply for the post.[For other conditions regarding age relaxations, please see para (2) of the General Conditions except para 2(i)]

7. Qualifications: I. a) M.Sc (Clinical Psychology) or any other

equivalent qualification from a UGC recognized University/Institute owned by Government of Kerala/ National Institutes of Government of India.

OR

- b) M.A/M.Sc in Psychology or any other equivalent qualification from a UGC recognized University/Institute owned by Government of Kerala/ National Institutes of Government of India.
- II. M.Phil in Clinical Psychology or equivalent 2 year course from a RCI approved University/ College/Institution owned by Government of Kerala/National Institutes of Government of India /UGC recognized University.
- III. Rehabilitation Council of India Registration as "Clinical Psychologist".

Note:-

- 1. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- 2. In the case of difference in original caste/ community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/ Community Certificate at the time of certificate verification.

Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must

quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.

- (b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calender itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
