Note:- Those who have passed the KGTE Typewriting before January 2002, should produce separate certificate in "Computer word processing or its equivalent" obtained after a course of study of minimum 3 months duration.

- **Probation**:- The candidate selected to the post shall from the date of appointment be on probation for a period of two years on duty within a continuous period of three years.

No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission.
