5. Method of Appointment: Direct Recruitment(from among candidates belonging to the Muslim Community only).

Note: Applications of candidates belonging to communities other than Muslim will be summarily rejected. Individual communication regarding the rejection of their application will not be issued.

6. Age Limit : **20-49.** Only candidates born between 02/01/1972 and 01/01/2001 (both dates included) are eligible to apply for this post. Including relaxation in Part-II para 2(i) of the general conditions. (For other conditions regarding age relaxations, please see para 2 of the Part-II general conditions.) Except para 2(i).

Qualifications:-

- 1. A Post graduate Degree in Ayurveda in the concerned subject from any of the Universities in Kerala or from any other University recognized by any of the Universities in Kerala
- 2. Permanent 'A' class Registration with Travancore Cochin Medical Council(Council of Indigenous Medicine)

NOTE: 1) Post graduate degree in the concerned subject has been made compulsory for appointment by direct recruitment to the post of Assistant professor.

- 2)If post-graduate holders of any subject are not available, post-graduate qualification prescribed by Central Council of Indian Medicine shall be admissible for that subject from time to time.
- 3) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of the verification then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- 4) In the case of difference in original Caste/Community claimed in the application and that entered in S.S.L.C book, the candidate shall produce a Gazette Notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of Certificate Verification.
- 5) Rule 10(a) (ii) of KS& SSR Part II is applicable.
- **8. Probation:-** Every person appointed to this post shall from the date on which he joins duty be on probation for a total period of two years on duty within a continuous period of three years .

9) Mode of submitting Application:-

Candidates who have registered can apply by logging on to their profile using their User-ID and password. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The applications will be summarily rejected if noncompliance with the notification is found in due course of processing. Original documents to prove qualification, Experience, Community, age etc. have to be produced as and when called for.
- b) If a written/OMR/Online Test is conducted as part of this selection candidates shall submit a confirmation for writing the examination through their One Time Registration Profile.
