Applications are invited from qualified **Scheduled Caste/Scheduled Tribe** candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile.

1 Name of Department : Kerala Vocational Higher Secondary

Education

2 Name of post : Non Vocational Teacher in Physics (Senior)

(Special Recruitment from SC/ST)

3 Scale of pay : ₹39,500-83,000

4 No. of Vacancy : 03 (Three)

Note:- The above vacancies are now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years, provided that the said list will not continue to be in force if a new list is published after the expiry of the minimum period of one year. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from Scheduled Caste/Scheduled Tribe during the currency of the list. Candidates shall also be advised from this list against vacancies exclusively reported for Scheduled Tribes and only in the absence of Scheduled Tribe candidates in this list, fresh notification for Scheduled Tribes will be issued for vacancies reserved exclusively for them.

5 Method of Appointment : Direct Recruitment (Special Recruitment from Scheduled Castes/Scheduled Tribes).

Note:- Applications received from candidates other than Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6 Age : 23-45, (Only Candidates born between

02.01.1976 and 01.01.1998 (both dates included) are eligible to apply for this post) No other age relaxation will be allowed.

Note:- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7 Qualifications

- **I.** Master's Degree in Physics with not less than 45% marks awarded by any of the Universities in Kerala or an equivalent qualification
- **II.** (1) B.Ed Degree in the concerned subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent there to by a University in Kerala.
- (2) In the absence of persons with B.Ed.Degree in the concerned subject, B.Ed. Degree in the concerned faculty as specified in the Acts and Statutes of any of the Universities in Kerala.
- (3) In the absence of persons with B.Ed Degree as specified in items (1) and (2) above, persons with B.Ed Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent there to by any of the Universities in Kerala.
- **III.** Must have passed the State Eligibility Test in the concerned subject for the post of Non Vocational Teacher conducted by Government of Kerala or by the agency authorized by the State Government.

Note:- Persons who have acquired M.Ed. in the concerned subject from a recognised University in Kerala are exempted from B.Ed. Qualification.

Exemptions

- 1) Those persons who have passed the State Level Eligibility Test for the post of College Lecturers conducted by Government of Kerala are exempted from the State Eligibility Test for Non-Vocational Teacher.
- **2)** Those persons who have passed the State Eligibility Test for the post of HSST conducted by the Government of Kerala are exempted from the State Eligibility Test for Non-Vocational Teacher.
- **3)** Those persons who have passed the National Eligibility Test/Junior Research Fellowship shall be exempted from passing the State Eligibility Test.
- **4)** Persons with Ph.D/M.Phil/M.Ed Degree shall be exempted from passing the State Eligibility Test provided the M.Phil in the concerned subject should be one awarded by any of the Universities in Kerala or recognized as equivalent by any of the Universities in Kerala.
- 5) Those who have submitted PhD Thesis and passed MPhil shall be exempted from SET upto the time of exemption granted by the UGC from time to time as in the case of candidates having the above qualifications from passing NET.

Explanation:

Non Vocational Teacher means full time post of Non Vocational

Teacher having work load of 15 periods or more per week per subject

Probation:

Every person appointed to the post shall from the date on which he/she joins duty be on probation for a total period of two years

on

duty within a continuous period of three years.

Note:

- 1) Rule 10 (a) (ii) of Part II KS&SSR is applicable for this selection.
- 2) Those candidates who have claimed equivalency for qualifications should produce the Government order proving the same at the time of certificate verification in order to consider as equivalent.
- 3) If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce Community Certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

8 Mode of Submitting application

A Candidates must register as per ONE TIME REGISTRATION with the official Website Kerala Public Service Commission of www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age. Community

etc. have to be produced as and when called for.

- **B** If written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
- C Appropriate disciplinary action as per Rule 22 of KPSC Rules of Procedure 1976 shall be initiated against those candidates who submit applications with bogus claims of qualifications regarding education, experience etc and attend or abstain from attending examinations after providing confirmation.
