6 Age : Must not have completed 41 years of age on 1st

January 2021.

Only Candidates born on or after 02.01.1980

are eligible to apply for this post.

(No other age relaxation will be allowed.)

Note:- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7 Qualifications

B.A. / B. Sc. & B. Ed

Desirable: Master Degree in School Subjects & Education (ie. MA/M.Sc. /M. Ed.) Etc.

Note:

If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce Community Certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

Probation:

Every person appointed shall from the date on which he completes the training prescribed, be on probation for a total period of 2 years within a continuous period of three years.

The probationer recruited direct shall within the prescribed period of probation pass the following tests

- (i) Account Test (Lower)
- (ii) Kerala Education Act and Rules
- (iii) Manual of Office Procedure

Training

Every person appointed shall undergo such a training as may be prescribed by the Government from time to time.

8. Method of Submitting application:

(A) Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep

- a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.
- **(B)** If written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
- **(C)** Appropriate disciplinary action as per Rule 22 of KPSC Rules of Procedure 1976 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc and attend or abstain from attending the examination after providing confirmation.
- **(D)** Those who have Aadhaar Card should add Aadhaar Card as ID Proof in their profile.
