9. Method of submitting applications:-

(a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala **Public** Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password.
