Applications are invited online only by "ONE TIME REGISTRATION" from qualified candidates belonging to Scheduled Caste and Scheduled Tribe communities of Kerala State for appointment in the under mentioned post in Kerala Government Service. Before applying for the post, candidates shall register as per One Time Registration Scheme through the official website of Kerala Public Service Commission.

1 Department : Kerala Higher Secondary Education

2 Name of Post : Higher Secondary School Teacher (Junior) Arabic

Explanation: Higher Secondary School Teacher (Junior) means Part-time post of Higher Secondary School Teacher.

3 Scale of pay : ₹ 45,600-95,600/-

4 Number of vacancies : Scheduled Caste-13 (Thirteen) - Cat. No. 417/2021 Scheduled Tribe -02 (Two) - Cat. No. 418/2021

The above vacancies are now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for the above mentioned communities, but remain unfilled due to the paucity of candidates during the currency of the Ranked list published on 16.01.2008 or three years from the date of publication of this NCA Ranked List whichever is earlier. This is the tenth NCA notification due to the non availability of qualified candidates for the post as per the Gazette notification dated 13.05.2009, 16.04.2010, 31.03.2011, 31.12.2011, 31.01.2013, 30.11.2013, 29.09.2015, 30.05.2017 & 14.11.2018 vide category numbers 163/2009, 93/2010, 30/2011, 547/2011 & 548/2011, 14/13 & 15/13, 489/13 & 490/13, 313/15 & 314/15, 167/17 & 168/17, 221/18 & 222/18 respectively.

5 Method of appointment

: Direct Recruitment from among Scheduled Caste and Scheduled Tribe community. In the absence of qualified SC candidates, application of ST candidates will also be considered and vice versa.

Note:-Applications of candidates belonging to communities other than SC & ST community will be summarily rejected. Individual communication regarding the rejection of their application will not be issued. Separate Application shall be submitted to each category.

6 Age limit

20-45 [Only candidates born between 02.01.1976 and 01.01.2001 (both dates included) are eligible to apply for this post.] including para 2(i) of the General conditions.

Note:- For other conditions regarding age relaxation, please see para 2 except para 2(i) of part II General conditions of the Gazette.

7 Qualifications

- : 1. Master's Degree in the concerned subject with not less than 45% marks from any of the Universities in Kerala or a qualification recognized as equivalent thereto in the respective subject by a University in Kerala (As per G.O. (MS)No.288/15/Gl.Edn. Dated: 13.11.15).
 - 2. (i) B.Ed in the concerned subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by any University in Kerala.
 - (ii) In the absence of persons with B.Ed. Degree in the concerned subject, B.Ed Degree acquired in the concerned faculty as specified in the Acts and Statutes of any of the Universities in Kerala.
 - (iii) In the absence of persons with B.Ed. Degree as specified in item (i) and (ii) above, persons with B.Ed. Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognized as equivalent thereto by any of the Universities in Kerala.
 - 3. Must have passed the State Eligibility Test (SET) for the post of Higher Secondary School Teachers conducted by the Government of Kerala or by the agency authorized by the State Government.

Note: 1. Rule 10 a(ii) of part II of KS&SSR is applicable.

2. In the absence of B.Ed Degree holders, candidates having Master's Degree with not less than 45% marks and who have passed the State Eligibility Test (SET) will be considered. Preference will be given to those who have acquired Ph.D/M.Phil degree or qualified at Junior Research Fellowship/National Eligibility Test. The teachers appointed under this provision will have to acquire B.Ed Degree at their own expense within five years from the date of entry in service.

- 3. Those who have passed Language Teachers Training Course are exempted from acquiring B.Ed. Qualification.
- 4. Persons who have acquired M.Ed in the concerned subject recognized by any University in Kerala are exempted from B.Ed qualification.
- 5. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Equivalency Certificate/Government Order to prove the equivalency at the time of certificate verification, then only such qualification shall be treated as equivalent to the prescribed qualification.
- 6. In the case of difference in original Caste/Community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Community Certificate at the time of certificate verification.

Exemptions:

- 1. Those persons who have passed the State Level Eligibility Test (SLET) for the post of College Lecturers conducted by Government of Kerala are exempted from passing the State Eligibility Test for Higher Secondary School Teachers.
- 2. Those persons who have passed the National Eligibility Test/Junior Research Fellowship shall be exempted from passing the State Eligibility Test.
- 3. Persons with Ph.D/M.Phil/M.Ed. degree shall be exempted from passing the State Eligibility Test provided the M.Phil in the concerned subject should be one awarded by any of the Universities in Kerala or recognized as equivalent by any of the Universities in Kerala.
- 4. The teachers who have completed 10 (ten) years of approved teaching service at the High School level in the General Education subordinate service shall be exempted from passing the State Eligibility Test.

8 Mode of submitting Application:-

- (a) Separate Application shall be submitted to each category.
- (b) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by log in on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for the post. The photograph uploaded should be one taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed

legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondence with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original Documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

- (c) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
- (d) Appropriate disciplinary action as per KPSC Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
- (e) Candidates who have ADHAAR card should add ADHAAR Card as I.D Proof in their profile.
