Notes:-

(i) The above Vacancies are now in existence. Separate Ranked Lists will be prepared for the above districts in pursuance of this notification. The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from Scheduled Castes/ Scheduled Tribes during the currency of the list. Candidates against vacancies reported exclusively for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list fresh notification for vacancies reserved exclusively for Scheduled Tribes will be issued. In case no candidate is advised from the ranked list till the expiry period of three

years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.

- (ii) Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction, and if he is selected, his name will be removed from the Ranked List and disciplinary action will be taken against him. Candidates should submit the application for this post to the concerned district and should note the name of that District against the relevant column of the online application.
- (iii) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No.154/71/PD dated, 27/05/1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service in the former district, even if transfer is allowed after five years, it will be subject to the rules in G.O. (MS)No.36/91,P&ARD dated 02/12/1991. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (iv) Candidates from the Ranked List for district wise selection will be advised for appointment against the Head quarters vacancies also. As per the provision in G.O(Ms)154/71/PD dated 27.05.1971 appointment against the Headquarters vacancies will be started from Thiruvananthapuram District. Separate option need not be given for this.
- (v) If the caste claim in the application differs from the caste noted in S.S.L.C., then such changes are to be published in the Gazette and the same should be produced along with the Caste Certificate issued by the Revenue Authorities at the time of One Time Verification or as and when required by the Commission.

<u>Note:-</u>Applications received from candidates other than Scheduled Caste/ Scheduled Tribe will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued. 6. Age Limit : 18-44 Only candidates born between 02.01.1977 and 01.01.2003 (both dates included) only are eligible to apply for this post.

Note:- 1) For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years of age

7. Qualifications:-

- i. A Pass in Standard VII (Redundant qualification :III Forum)
- ii. Must possess valid Driving License of three years standing to drive Medium/Heavy Goods/Passenger Motor vehicles with Drivers Badge.
- iii. Proficiency in Driving-Medium/Heavy Goods/Passenger Motor Vehicles which is to be proved by a Practical Test including 'T' test and Road test conducted by Kerala Public Service Commission during the course of selection. Only those who have passed 'T' test are eligible for road test.

Note: 1. Rule 10 (a)(ii) of Part II of KS & SSR is applicable.

- 2. Candidates claiming equivalent qualification should produce relevant Govt. Orders bearing verification to prove that the qualification claimed is equivalent to the prescribed qualification for the post.

- 1) Differently abled candidates are not eligible to apply for the post.
- 2) Candidates should furnish the full details regarding the Driving License and experience in driving in the relevant column (qualifications) of the application form.

- Candidates called for the practical test will have to produce Medical certificate in the prescribed form in original containing all relevant details as required in para 7 (iv) above (except iv b) from a Medical Officer not below the rank of an Assistant Surgeon. - 4) Candidate should possess current valid Driving License and badge through out all the stages of selection process i.e on the last date of receipt of application, OMR Test/Online Test, Practical Test and interview.



8 Method of Submitting applications:-

Candidates must register as per "ONE TIME REGISTRATION" with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post.Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of the photograph uploaded. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date

of taking. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The Application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, community, age etc. have to be produced as and when called for. Candidates who have AADHAAR card should add AADHAAR card as I.D Proof in their profile.

- If a Written Test/OMR/Online Examination is conducted as a part of this selection, Candidates shall submit a confirmation for writing the examination through their 'One Time Registration' Profile. Such candidates alone can generate and download the Admission Ticket in the last 15 days till the date of test.
