Wayanad – 01 (ST only) Kasaragod – 01 (ST only)

Notes: i) Separate Ranked Lists will be prepared for the above districts in pursuance of this notification. The Ranked List thus prepared and published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Tribes during the currency of the list.

ii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List so prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if, transfer is allowed after five years, it will be subject to the orders contained in G.O(MS) No. 4/61/PD, dated 02.1.1961. Candidates already in Government service, holding the post in any one district are restricted from applying for the same post in another district. But they can apply for higher posts when notified.

- iii) Applications should not be sent to more than one District in response to this notification. If applications are sent contrary to the above direction and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her. Candidates should submit application for the post to the district office concerned, where the vacancy is existing and should note the name of that district against the relevant column of the online application.
- iv) In case of change in caste noted in the SSLC book, candidates must claim their original caste in the application and shall produce Community Certificate issued by the Revenue authorities and the original Gazette Notification publishing the change of caste at the time of OTR verification for selection to the above post.

Direct Recruitment (Special Recruitment from among Scheduled Tribes only)

<u>Note</u>: Applications received from candidates other than Scheduled Tribe will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. **Age** : 19-41. Only Candidates born between 02.01.1980 and 01.01.2002 (both dates included) are eligible to apply for this post.

Note: In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (fifty) years.
