(ii) The candidates belonging to above reservation community shall submit application for the post to any one of the above district and shall note the name of that district against the relevant column of the online application. Applications should not be sent to more than one district in response to this notification. If applications are sent contrary to the above direction, and if he/she is selected, his/her

name will be removed from the ranked list and disciplinary action will be taken against him/her.

- (iii) The sixth NCA notification is issued due to paucity of qualified candidates belonging to Scheduled Caste Converted to Christianity (SCCC) community after the issuance of First NCA notification vide category No.502/2014 (Kozhikkode), 457/15 (Kasaragod), Second NCA notification vide Category No.389/16 (Kozhikkode), 184/17(Kasaragod), Third NCA Notification vide category No.194/18 (Kozhikkode and Kasaragod), fourth notification vide Category No.467/19 (Kozhikkode and Kasaragod) and fifth NCA Notification vide Category No.361/2020(Kozhikkode and Kasaragod).
- (iv) In case of change in Caste/Community noted in the SSLC book, candidates must claim their original caste/community in the application and shall produce Non-Creamy Layer Certificate issued by the Revenue Authorities and the original Gazette notification publishing the change of caste/community at the time of OTR verification for selection to the above post.
- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher/lower posts when notified.

6. **Age**

18-39, ie, candidates born between 02.01.1982 and 01.01.2003 (both dates included) are only eligible to apply for this post. (Including the relaxation as per Para 2(i) of the General Conditions)

In the case of candidates belonging to Adult members of Scheduled Caste and their children when such adult members are converted to Christianity the upper age limit will be 41 years, ie, such candidates should be born between 02.01.1980 and 01.01.2003 (both dates included)(Including the relaxation as per Para 2(i) of the General Conditions)

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 (fifty) years.

7. Qualifications:

- i) Pass in S.S.L.C or its equivalent.
- ii) A pass Certificate obtained after successful completion of Nurse-Cum-Pharmacist Training Course (Homoeopathy) conducted by the Government of Kerala / A pass in Certificate Course in Pharmacy (Homoeopathy) conducted by the Government of Kerala / its equivalent qualification recognised by the Government.

Note:-

- 1. KS&SSR Part II Rule 10 (a) (ii) is applicable.
- 2. Candidates claiming equivalent qualification should produce relevant Government Orders during OTR verification to prove that the qualification claimed is equivalent to the prescribed qualification for the Post.

8. Mode of submitting applications:-

Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. - 10. If Written Test/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely.
