Note:- Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6 Age 25-46

> Only Candidates born between 02.01.1975 and 01.01.1996 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

#### 7 **Qualifications:**

1) Masters Degree in Psychology or Education with not less than 50% marks from a recognized University.

- 2) a) Specialization in Vocational guidance OR
  - (b) Diploma in Vocational guidance granted by a State Vocational Guidance Bureau or a recognized Teachers Training College in the State `or Masters Degree in any subject from a recognized University.
- 3) Experience in the field of educational or vocational guidance work for a period of not less than five years of which at least three years should be in a supervisory capacity from any organization of Government/Quasi Government or from any institution recognized with or recognized by Government.

(The experience should be one gained or acquired after the academic qualification).

- 1. In the case of Ex-Servicemen, in addition to the above qualification, experience in HRD or Military Recruitment for 10 years shall be insisted for direct recruitment.
- 2. Rule 10(a)(ii) of part II of KS&SSR is applicable
- **3.** Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- 4. If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from the revenue authority concerned and the Gazette Notification for the same at the time of certificate verification.

**Probation**: Every person appointed to this post shall from the date on which he joins duty be on probation for a total period of two years on duty, within a continuous period of three years.

## 8 Method of submitting Applications

(A) Candidates must register as per ONE TIME REGISTRATION with the Website of Kerala Public Service www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if non-compliance with the notification is found in due

course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

- **(B)** If written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
- **(C)** Candidates who erroneously claim qualification, experience etc and attend or abstain from attending the examination after providing confirmation are liable for disciplinary action as stipulated in Rule 22 of KPSC Rules of Procedure 1976.
- **(D)** Those who have Aadhaar Card should add Aadhaar Card as ID Proof in their profile.
