(b) National Apprenticeship Certificate in the appropriate trade with one year experience after obtaining the certificate.

OR

(c) Diploma in the appropriate branch of Engineering from a Government or Government Recognized polytechnic or its equivalent qualification.

**8. Probation :** Every person appointed to this post shall, from the date on which he/she joins duty, be on probation for a total period of two years of duty within a continuous period of three years.

### 9. Method of submitting applications:-

Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded in the profile should be one taken after 31.12.2012. Candidates who register for the first time through One Time Registration from 1.1.2022 shall upload photograph taken within six months. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission.

Application once submitted is received as provisional and the details cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if noncompliance with the notification is found in the due course of processing. Original documents to prove qualification, experience, community, age etc. have to be produced as and when called for.
