- <u>Note:-i</u> The above vacancies are now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Caste/Scheduled Tribe during the pendency of the list. Candidates against vacancies exclusively reported for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribes for vacancies reserved exclusively for them will be issued.
 - ii The name of the post, qualification and related conditions for selection is notified as per the provisions included in G.O(P)No.89/2014/Home dated 06.05.2014 and GO(P)No.266/2010/Home dated 09.12.2010.
 - (a) Every person appointed to the post shall from the date on which he joins duty be on probation for a total period of two years on duty within a continuous period of three years.
 (b) They shall undergo in-service training as prescribed by the Head of Department.

(c) They shall pass Kerala Jail Subordinate Officers test within the

period of probation unless they have already passed the test.(d) Statewise Seniority List will be maintained on the warder establishment for the purpose of promotion to other categories.

- 5 Method of Appointment : Direct Recruitment (State wide) (Special Recruitment from Scheduled Castes/Scheduled Tribes only).
- **Note:-** Applications received from candidates other than Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.
- 6 Age : 18-41 Only Candidates born between 02.01.1981 and 01.01.2004 (both dates included) are eligible to apply for this post.

Note:- In the absence of qualified candidates within the age limit, the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (fifty) years.

7 Qualifications

- **1.** Pass in S.S.L.C or its equivalent qualification.
- *Note:* i) Part II Rule 10(a)ii of KS&SSR regarding qualification is applicable for this selection.

ii) Those candidates who have claimed equivalency for qualifications should produce the Government Order to prove the same at the time of verification in order to considered as equivalent. Candidates claiming higher /eqivalent to the qualification for which equivalency is prescribed in the notification should produce equivalency certificate from concerned institution or Government order proving the equivalency.

iii) If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from the revenue authority concerned and the Gazette Notification for the same at the time of certificate verification.

- (iv) Must qualify in any five (5) events out of Eight (8) events of the National Physical Efficiency "One Star" Standard Test, as specified below.

Note:- The physical measurement of candidates will be taken at the time of physical efficiency test and those who do not possess the prescribed physical measurement will not be admitted for the physical efficiency test. If accidents or injuries happened to candidate while participating in the Physical Efficiency Test, he will not be given further chance to participate in the test. The candidates should produce at the time of Physical Efficiency Test, a Medical Certificate in original in the form prescribed hereunder certifying to their physical fitness and eye sight without glasses. The Medical Certificate

should be one obtained from a Medical Officer under the Government not below the rank of an Assistant Surgeon/Junior Consultant and the same shall be uploaded in the OTR profile by the candidates at the time of certificate verification.
