(i) Candidates shall apply only through online by onetime registration in the website www.keralapsc.gov.in. Application submitted in any other manner will be summarily rejected

- (ii) A Ranked List will be prepared for the above district in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force for a period of one year and maximum period of 3 years provided the said list will not continue in force if a new list is published after the expiry of the minimum period of one year. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any reported during the currency of the List. Incase no candidate is advised from the ranked list till the expiry period of three years, the duration of the Ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- (iii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O.(MS) No.154/71/PD dated, 27/05/1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O.(MS)No.36/91/P&ARD dated 02/12/1991. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (iv) Candidates should submit applications for the post to the above district where the vacancy is existing and should note the name of the concerned district against the relevant column in the online application.

Candidates must register as per "ONE TIME REGISTRATION" with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post.Candidates who have registered can apply by logging on to their profile using their User-ID and password.
