Applications are invited from qualified **Scheduled Tribe** candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Kerala Public Service Commission after One Time Registration. Candidates who have already registered can apply through their profile.

1. **Department** : Agriculture Development and Farmer's Welfare

2. Name of post : Tractor Driver Gr. II (Special Recruitment for ST only)

3. Scale of pay : ₹ 18,000 - 41,500/- (PR)

4. Number of Vacancies : District wise : Kannur - 01

Notes: i) The above vacancy is now in existence. The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year or till the expiry of three years which ever is earlier. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Tribe during the validity of the list.

- ii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List so prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if, transfer is allowed after five years, it will be subject to the rules in G.O(MS) No. 4/61/PD, dated 02.1.1961. Candidates already in Government service, holding the post in any one district are restricted from applying for the same post in another district. But they can apply for higher posts when notified.
- iii) If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

5. **Method of appointment** : Direct Recruitment

(Special Recruitment from among Scheduled Tribes only)

<u>Note</u>: Applications received from candidates other than Scheduled Tribes will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. **Age** : 19-41. Only Candidates born between 02.01.1981 and 01.01.2003 (both

dates included) are eligible to apply for this post.

Note: In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (fifty) years.

7. Qualifications:-

- (1) Diploma in Agricultural and Rural Engineering awarded by the Kerala Agricultural University.
- (2) In the absence of persons with the qualifications prescribed under item 1 mentioned above the persons with the following qualifications will be considered.
- i) National Trade Certificate in any of the following trades from the I.T.I
 - (a) Mechanic (Tractor)
 - (b) Mechanic (Motor Vehicle)
 - (c) Mechanic (Diesel)
 - (d) Fitter

- ii) Practical Experience of not less than one year in the trade. The Practical experience should be one acquired after the acquisition of I.T.I Trade Certificate. Proficiency in the field of work will be assessed in a practical test conducted by the Public Service Commission.
- (3) The candidates should possess a valid Tractor Driving License.
- Note: 1. Rule 10 a (ii) of Part II KS & SSR is applicable for selection to this post.
 - 2. Candidates claiming higher/ equivalent qualification should produce equivalency certificate from the concerned Institution or Government Order proving the equivalency at the time of certificate verification.
 - 3. Candidates should possess current Tractor Driving license on all stages of selection ie. on the last date of application, the date of OMR test/Online test, Practical test, interview, etc.

10 Mode of submitting application:-

- (a) Candidates must register as per ONE TIME REGISTRATION with the official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be taken after 31.12.2012. Candidates who create new profile from 01.01.2022, should upload the photograph taken within 6 months. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded and that satisfies all requirements shall be valid for 10 years from the date of taking the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Original documents to prove qualification, age, community etc. have to be produced as and when called for.
- (b) Candidates who have Aadhaar card should add Aadhaar card as I.D proof in their profile.
- 11 **Last date for submission of application**: 02.11.2022 Wednesday up to 12 midnight.
- 12 If a Written/OMR/Online Test is conducted as part of this selection, candidate shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidate alone can generate and download the admission tickets in the last 15 days till the date of test. The application of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the examination programme itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.

Appropriate disciplinary action as per Rule 22 of the KPSC Rules of Procedure 1976 shall be initiated against those candidates who submit application with bogus claims of qualification regarding education, experience etc and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.

- Paragraphs two, three and twenty five (in para 25, except the conditions laid down in Rule 3 (c), Part II of the Kerala State and Subordinate Service Rules) are not applicable to this selection.
- Appointments will be made on the basis of the rank secured by the candidates in the ranked list prepared in pursuance of this notification subject to the conditions laid down in G.O (P) No. 21/76/PD dated, 17.01.1976 and G.O (P) No. 25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
