## Note:-

- 1. The above vacancy is now in existence and arose as the vacancy earmarked for the Scheduled Caste community was not filled from the ranked list published on 12.04.2019 (General Category, Cat. No. 378/2017) due to the paucity of candidates belonging to the above community. The ranked list published as per this notification will be valid until the above vacancy is filled or three years from the date of publication, whichever is earlier. This is the second NCA notification issued due to non-availability of qualified candidates belonging to the above Community in response to the first NCA notification (Gazette date: 03.08.2020, Category No. 042/2020).
  - 2. The selection in pursuance of this notification will be made on statewide basis.
- 3. As per Rule 184 of KCS every person appointed to this post shall from the date on which he/she joins the duty be on probation for a period of two years on duty within a continuous period of three years.

## 5. Method of appointment : Direct Recruitment

**6. Age**: 18-45 years. Candidates born between 02.01.1977 and 01.01.2004 (Both dates included) are eligible to apply for this post.

- 2. A pass with intermediate examination of ACA/AICWA
- 3. 3 (three) years experience in Executive Cadre in the Accounts Department of a reputed organisation

- 2. Those candidates who have claimed equivalency for qualifications should produce the Government order proving the same at the time of certificate verification in order to consider as equivalent.

# 7. Qualifications:-

(1) A pass in SSLC Examination conducted by the Commissioner for Government Examinations, Kerala or its equivalent.

OR

A pass in Pre-degree examination conducted by any of the Universities in Kerala or any examination recognized by any such Universities in Kerala as equivalent to Pre-degree examination.

OR

A pass in Higher Secondary Examination conducted by the Board of Higher Secondary Examinations, Kerala or any other Examinations recognized by Government as equivalent thereto.

(2) A pass in TTC Examination conducted by the Commissioner for Government Examinations, Kerala.

A Degree in any subject and B.Ed/B.T/L.T conferred or recognised by the Universities in Kerala. **Note :-** As per G.O(R T)No.3280/13/G.Edn dated 5.8.13, the TTC qualification has been renamed as D.Ed (Diploma in Teacher Education) and subsequently as per G.O(RT)No.1700/18/G.Edn. dated 5.5.18 and G.O(RT)No.2009/18/G.Edn dated 30.5.18 again renamed as D.El.Ed (Diploma in Elementary Education). The candidates who have possessed D.Ed/D.El.Ed qualification shall also be considered for the selection.

(3) Must have passed the Kerala Teacher Eligibility Test (K-TET) for this post conducted by the Government of Kerala

# Exemption:

- 1. Candidates who have qualified CTET/NET/SET/M.Phil/Ph.D in the respective subjects and M.Ed in any subject are exempted from acquiring TET (G.O. (P) No. 145/16/G.Edn. Dated 30.08.16, G.O. (P) No. 206/16/G.Edn. Dated 08.12.2016 and G.O(P)No.15/2020/G.Edn Dated 09.10.2020).
- 2. As per the conditions laid down in Government Circular No. 1866829/J3/2017 G. Edn. Dated 09.03.2018 those who passes CTET primary stage and CTET Elementary stage were excluded from KTET Cat. I & KTET Cat. II respectively. Also CTET qualification can't be considered as an alternative qualification for KTET Cat. III and Cat. IV.

# <u> Note</u>:-

- (I) M.Phil in the concerned subject be the one awarded by any of the Universities in Kerala or recognised as equivalent by any of the Universities in Kerala.
- (ii) Candidates who have not studied the Regional Language Malayalam either under Part-I or Part-II or as medium of instruction for SSLC will not be eligible for appointment to the post.[G.O(RT) No. 534/2002/G.Edn dated 19.03.2002, G.O(MS) No.44/75/G.Edn. Dated 29.01.1975.]. - (iii) If there is written (Descriptive/OMR) test the Question paper will be in malayalam. The candidates should answer the questions in Malayalam. In the case of OMR answer script, answers are to be marked as instructed.

## **NB:** KS & SSR part II Rule 10 a (ii) is applicable for selection to this post.

- (ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O.(MS) No.122/75/G.Edn. dated 27.05.1975 and G.O.(MS) No.50/70/PD dated 12/02/1970).
