Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Candidates included in the Short List are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (9) SC/ST Candidates included in the Short List are required to produce Community Certificate (in form III/Digitally Signed Certificate) issued by the Competent Revenue Authority not below the rank of a Tahsildar as specified in Kerala Gazette and candidates belonging to other reservation communities are required to produce a Non Creamy Layer Certificate as per G.O(P)No.81/09/SC/ST/DD dated 26.09.2009 issued by the competent Revenue Authority at the time of Verification

Note :- (9) Copy of answer scripts of the OMR Test held on **13-04-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Detailed instructions regarding this will be noted in the Ranked List to be published for the post.
