6. Age Limit : 35-46.

35-46. Only candidates born between 02.01.1976 and 01.01.1987 (both dates included) are eligible to apply. (For other conditions regarding age relaxations, please see para (2) of Part II General Conditions of the Gazette notification).

Note :- 1) Candidates belonging to scheduled Castes / Scheduled Tribes and Other backward Communities and not already in the service of the Government shall be eligible for age relaxation as provided in sub rule (c) of Rule 10 of Part II of Kerala State and Subordinate Service Rules 1958 subject to the specific condition that the upper age limit shall in no case exceed fifty years

2) The upper age limit for recruitment to the post shall in the case of any candidate already in the State Planning Board including candidates belonging to SC,ST and OBC be 50 years.

OR

c) A First Class or High Second Class Masters Degree in Economics/ Mathematics with Diploma or Training in Statistics with specialization in Econometrics and Economic forecasting from a recognized University or Institution and seven years experience in Economic Planning and Models and in the application of Economic Methods in Macro and Micro Level Planning Desirable: a) Experience in the application of Econometric methods to Planning problems either in Government Institutions or in recognized Universities or other Institution

- b) Published work in Economic Planning involving the use of quantitative methods
- **Note** i) Rule 10 (a) (ii) of Part II of KS&SSR is applicable.
  - Only a pass in Masters Degree in the concerned subject is necessary in the case of candidates already in the Department.
  - iii) The qualification of experience prescribed for the post shall be one acquired after the acquisition of academic qualification prescribed for the post

Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for the post. The photograph uploaded should be one taken after 31.12.2012. Candidates creating new profile from 01.01.2022 should upload photograph taken within six months. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission.
