The photograph once uploaded meeting all requirements shall valid for 10 years from the date of taking photograph.Candidates creating new profile on or after 01.01.2022 shall upload photograph taken with in six months. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information in their profile. They must quote the User ID for further communication with the Commission. Applications once submitted is received as provisional and the details cannot be deleted or altered after submission.
