This is the Second NCA Notification issued due to the non – availability of eligible candidates belonging to the above mentioned community in response to the first NCA Notification published in the gazette dated 15/10/19 (Cat No: 165/19).

5. Method of appointment : Direct Recruitment from candidates belonging to the Ezhava / Thiyya / Billava community only.

Note :- Applications submitted by candidates belonging to the communities other than the above will be summarily rejected. Individual communication regarding the rejection of their application will not be issued.

- 2. In addition to the qualifications prescribed in the notification, the qualifications recognized by executive orders, or standing orders of Government as equivalent to a qualification specified for a post, in the Special Rules or found acceptable by the Commission in cases where acceptance of equivalent qualifications is provided for in the rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post, shall also be sufficient for the post. 8. Mode of submitting applications :

- Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of (a) Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for the post. The photograph uploaded should be one taken after 31.12.2013. The newly registered candidates should upload photographs taken within six months of registration. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link 'My applications' in their profile. All correspondence with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original Documents to prove qualification, experience, age, Community etc. have to be produced as and when called for. The profile correction made by the candidates themselves or through the office of the KPSC on request after the last date fixed for the receipt of applications will not be reflected in the application. Such correction will come into effect only on the date on which correction have been made.
- (b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
- (c) The genuineness of the experience certificate shall be subjected to verification and legal action will be taken against those candidates who produce bogus certificates.
- (d) Appropriate disciplinary action as per Rule 22 of the Kerala Public Service Commission Rules of procedure shall be initiated against those candidates who submit applications with bogus claims of qualifications regarding education, experience etc and are liable to be disqualified for being considered for a particualr post or debarment from applying to the Commission either permanently or for any period or the invalidation of their answer scripts or products in a written / practical test or the initiation of criminal or other disciplinary action against them if they have already been appointed or any one or more of the above.
- (e) Candidates are required to acquaint themselves with the instructions given in the notification as Part II, General Conditions before submitting application for the post.
