- (i) One vacancy of the above post is set apart, owing to the absence of Differently Abled (DA) Candidates belonging to Low Vision Category and as per PWD Act 2016, for advising candidates belonging to the same DA candidates of Low Vision Category and in their absence General Category, from the Ranked List published in response to this Notification.

On such cancellation the appointing authority shall terminate the service of the candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

But the regular employees of the concern are not eligible for the above concession for further appointment. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.
