- (2) Differently Abled persons are not eligible to apply for the post.
- (3) Concessions for Differently Abled candidates contemplated in para 2 and 5 of the General Condition are not applicable for selection to this post.
- (4) In addition to the qualifications perscribed in the notification, the qualifications recognized by executive orders or standing orders of government as equivalent to a qualification specified for the post, in the Special Rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post, shall also be sufficient for the post. The copy of the government orders declaring equivalent /higher qualifications shall be produced as and when required by the Commission.

8 Mode of submitting Applications:-

(a) Candidates must register as per One Time registration scheme through the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have already registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for the post. The photograph uploaded should be one taken on or after 31/12/2013. Candidate who have created new profile should upload their photograph taken within a period of 6 months. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements

shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password .Before the final submission of application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link **My Applications** in their profile. All correspondence with the commission ,regarding the application should be accompanied with the print out of the application. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, Experience, Community, age etc. have to be produced as and when called for.

- (b) If Written Test /OMR/ Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile.
