Applications are invited from qualified **Scheduled Tribe** candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Kerala Public Service Commission after One Time Registration. Candidates who have already registered can apply through their profile.

1. **Department** : Various (Except NCC, Tourism, Excise, Police, SWD and Transport)

2. Name of post : Driver Cum-Office Attendant (HDV)(Special Recruitment from among

ST only)

3. Scale of pay : $\angle 25,100-57900/-$

4. **Number of Vacancies** : District wise

Notes:

I) A Ranked List will be prepared for Kottayam district in pursuance of this notification. The Ranked List thus prepared and published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment for Scheduled Tribes during the currency of the said list.

- ii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List so prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if, transfer is allowed after five years, it will be subject to the orders contained in G.O (MS) No. 4/61/PD, dated 02.01.1961. Candidates already in Government service, holding the post in any one district are restricted from applying for the same post in another district. But they can apply for higher posts when notified.
- iii) Candidates included in the Rank List for district wise selection will be advised for appointment against the Head quarters Vacancies also. As per the provision in G.O (MS) No.154/71/PD dated 27/05/1971, appointment against the Headquarters Vacancies will be started from Thiruvananthapuram District. Separate option need not be given for this. The conditions laid down in G.O(P)27/13/PD dated 28.09.2013 shall be applicable to the candidates thus appointed.
- iv) The nomenclature and nature of duty in respect of the above post is as per G.O(MS)29/15/P&ARD Date-19.11.2015.

5. **Method of appointment** : Direct Recruitment

(Special Recruitment from among Scheduled Tribes only)

Note: Applications received from candidates other than Scheduled Tribes will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

Note: In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (fifty) years.

7. **Qualifications:**

- I. A pass in Standard VII (Redundant qualification III forum).
- II. Must posses Valid Driving Licence of three years standing to drive Medium/Heavy Goods/Passenger Motor Vehicles with Drivers Badge.
- III. Proficiency in Driving-Medium/Heavy Goods/Passenger Motor vehicles which is to be proved by a practical Test including 'T' test and Road test conducted by Kerala Public Service Commission during the course of selection. Only those who have passed 'T' test are eligible for road test.

Note:

Rule 10(a)(ii) of Part II of KS & SSR is applicable.

"In addition to the qualifications prescribed in the notification, the qualifications recognized by executive orders or standing orders of Government as equivalent to a qualification specified for a post, in the Special Rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post, shall also be sufficient for the post. The copy of the Government orders declaring equivalent/higher qualifications shall be produced as and when required by the Commission."

- 1. Differently abled candidates are not eligible to apply for the post.
- 2. Candidates should furnish the full details regarding the Driving Licence and experience in driving in the relevant column (qualifications) of the application form.
- 3. Candidates, while attending the Practical test, will have to produce Medical certificate in the prescribed form in original containing all relevant details as given in para 7 (iv) above(except iv b) from a Medical Officer not below the rank of an Assistant Surgeon and a Medical Certificate regarding eye sight as per Para 7(iv) (b) from an Ophthalmologist in Government Service. - 4. Candidates should possess current Valid Driving Licence and badge through out all the stages of selection process i.e on the last date of receipt of application,OMR Test/Online Test,Practical Test and

5. Candidates from the ranked list prepared in response to this notification will be advised for appointment as per turn against Headquarters vacancy also.

8 Mode of submitting application:

- (a) Candidates must register as per ONE TIME REGISTRATION with the official website of Kerala Public Service Commission <u>www.keralapsc.gov.in</u> before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be taken after 31.12.2013. Candidates who create new profile should upload the photograph taken within 6 months. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded and that satisfies all requirements shall be valid for 10 years from the date of taking the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.

- Appointments are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O (Ms) 142/72/PD dated, 13.04.1972, G.O (Ms) 309/73/PD dated, 29.11.1973, G.O (P) No. 21/76/PD dated, 17.01.1976 and G.O (P) No. 25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Castes / Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.

Special instructions to candidates:-

- 14 In the case of difference in Caste/Community claimed in the application and that entered in SSLC book, the candidate shall produce a gazette notification in this regard, along with Community certificate at the time of certificate verification.
- 15 Candidates are required to acquaint themselves with the instructions given in the notification as Part II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.
