Direct Recruitment from among the eligible and qualified employees belonging to Scheduled Caste, LC/AI, Viswakarma, Scheduled Tribe, SCCC, Dheevara communities of the Member Societies affiliated to Kerala State Co-operative Agricultural and Rural Development Bank Limited.

Note:- (i) Applications submitted by candidates who are not regular employees of member societies affiliated to Kerala State Co-operative Agricultural and Rural Development Bank Limited and who belongs to communities other than Scheduled Caste, LC/AI, Viswakarma, Scheduled Tribe,SCCC, Dheevara will be rejected. Individual communication regarding the rejection will not be issued to such candidates.

7 Age:

18- 50 years. Candidates born between 02.01.1973 and 01.01.2005 (Both dates included) are eligible to apply for this post.

8 Qualifications:

1. Must have completed 3(Three) years regular service in any cadre in the Member Societies affiliated to the Kerala State Co-operative Agricultural and Rural Development Bank Limited and should be in service of the Member Society not only on the date of application but also on the date of appointment.

2. Graduation from a recognized University with JDC/HDC.

Note:-

1. Rule 10 (a) (ii) of Part II of KS&SSR is applicable.

9 Mode of submitting applications:-

Candidates must register as per ONE TIME REGISTRATION with the Official **(a)** Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User- ID and password. Candidates must refrain from creating multiple profiles, non-compliance of which shall lead to forfeiture of their candidature. Candidates must click on the 'Apply Now' button of the respective posts in the Notification link to apply for a post. The photograph uploaded should be one taken after 31.12.2013. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of the photograph. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. Candidates who create new profile should upload photograph taken within 6 months. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the

User- ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission.
