- The Candidates belonging to the above reservation communities shall submit application for this post to any one of the Districts where the Vacancy is existing for their communities and shall note the name of that district against the relevant column in the online application.
- (iii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27/5/1971. A candidate advised for appointment in one Revenue District from the ranked list prepared is not eligible for transfer to another district unless he/she completes five years continuous service in the former district. Even if transfer is allowed after five years, it will be subject to the rule in G.O (MS)No.4/61/PD dated 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher/lower posts when notified.

(including the relaxation as per Para 2(i) of the General Conditions)
- (ii) For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 (fifty) years, please see para (2) of the General conditions under part II of this Notification.

In addition to the qualifications prescribed in the notification, the qualifications recognized by executive orders or standing orders of Government as equivalent to a qualification specified for a post, in the Special Rules and such of those qualifications which pre-suppose the acquisition of the lower qualification prescribed for the post, shall also be

sufficient for the post. The copy of the Government orders declaring equivalent/higher qualifications shall be produced as and when required by the Commission.

8 Mode of submitting Applications:-

- Candidates must register as per ONE TIME REGISTRATION scheme through the Official Website of Kerala Public Service Commission <u>www.keralapsc.gov.in</u> before applying for the post. Candidates who have already registered can apply by logging in to their profile using their User ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification link to apply for the post. The photograph uploaded should be one taken after 31.12.2013. Candidate who have created new profile should upload their photograph taken within a period of 6 months. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading of photographs. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link My Applications in their profile. All correspondence with the commission, regarding the application should be accompanied with the print out of the application. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, Experience, Community, age etc. have to be produced as and when called for.
- (b) If written Test /OMR/ Online Test is conducted as part of this selection, candidate shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the admission tickets in the last 15 days till the date of test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Programme itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it. Candidates who have downloaded the Admission Tickets will alone be permitted to attend the examination. As per Rule 22 of the KPSC Rules of Procedure 1976, appropriate discipinary action will be taken against those candidates who submit application for the post with false claims of possession of prescribed qualification experience etc. and give confirmation for examination, irrespective of the fact that they have appeared or not for the examination.

- (b) Candidates are required to acquaint themselves within the instructions given in the notifications as part II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.
