Details regarding standards of vision should be clearly stated in the certificate as given above. Vague statements such as Vision "Normal", "Average", etc will not be accepted. Specification for each eye should be stated separately against each item. If the specifications are not as indicated above, the Officer issuing the certificate should notify whether the candidate has got better standards of vision or worse standards of vision, as the case may be. Otherwise the Certificate will not be accepted.

8.Training:

Any persons appointed to the post by Direct Recruitment shall undergo 6 months training in all branches of Forensic Science in the Forensic Science Laboratory. Any person appointed to a post of Scientific Officer by direct recruitment shall also undergo a training in that/ those discipline(s) of Forensic Science which will be dealt with in the division(s) of Forensic Science Laboratory to which he/she will be appointed/ transferred in a Forensic Science Laboratory or in the National Institute of Criminology and Forensic Science (NICFS), Government of India, New Delhi or similar institution to be decided by the Government on the advice of the Director General of Police for a minimum period of six months or for such period/periods is required to complete the course/courses of training in the institution/institutions to which he/she is deputed.

- 2 A Trainee will be entitled to the following benefits during the period of training.
 - a. A person appointed by direct recruitment will be eligible to draw an amount equal to the minimum of the scale of pay of the post and the usual allowances. He will be eligible for Travelling Allowances for to and fro journeys and journeys incidental to the training at the rates admissible to the officers drawing pay at the minimum of the scale of pay of the post under Kerala Service Rules.
 - Any other allowances like Compensatory Allowances, Warm Clothing Allowances etc.
 which Government may by General or Special Orders, sanction to officers deputed for
 travelling.
 - The period of training and transit will be inservice and treated as duty under Rule 12(7) (iii) Part I of Kerala Service Rules.
- **9.Test:** Every person appointed to this post shall within the period of probation, pass the Account Test for Executive Officers or Account Test (Lower) if he has not already passed the test.
- **10.Probation:** Every person appointed to the post shall on completion of the training, be on probation for a total period of two years on duty within a continuous period of three years.
- 11.Bond: Every person appointed to the post shall execute a Bond in such form as may be prescribed by the Government to serve the State Government for a minimum period of 5 years, after completion of training, failing which he will be liable to pay a sum of ₹25,000 (Rupees Twenty Five Thousand only) as liquidated damages to the Government in addition to the actual cost of training assessed by the Accountant General (A & E) , Kerala, Thiruvananthapuram.

12. Mode of submitting applications:-

(a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for the post. The photograph uploaded should be one taken after 31.12.2013. Candidate who have created new Profile from 01.01.2022 should upload their Photograph taken within a period of 6 months. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the print out of the application by clicking on the link 'My applications' in their profile. All correspondence with the Commission, regarding the application should be accompanied with the print out of the application. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original Documents to prove qualification, experience, age, Community etc. have to be produced as and when called for. The profile correction made by the candidates themselves or through the office of the KPSC on request after the last date fixed for the receipt of applications will not be reflected in the application. Such corrections will come into effect only on the date on which corrections have been made.

- (b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets prior to 15 days of the Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The period regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their profiles and in the mobile phone number registered in it.

13. Special Instructions to Candidates:-

- (b) Candidates are required to acquaint themselves with the instructions given in the notification as Part II, General Conditions before submitting application for the post. Applications which are not submitted in accordance with the terms and conditions laid down in the General Conditions are liable to be rejected.
