NOTE (1):- Since a common Online Test with common candidates was conducted for this post , the marks awarded to candidates included in this Ranked List and mark of Online test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be on the basis of the common test.

NOTE (2):- For Online Examination rechecking and revaluation are not allowed . Candidates who wish to obtain a print out of their Answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of **Rs. 335** (Rupees three hundred and thirty five only) via e-payment mode available in the portal. A period of **15** (**Fifteen**) days time to apply for print out of answer sheet will be allowed to candidates witheffect from the date on which the Ranked List is uploaded in the website of the Commission (**ie on or before 20.05.2024**). Application submitted in any other manner (i.e. via email/Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate.Printout of the answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for printout of the answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Printout of the answer sheet will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

NOTE (3) :- The entries put in column (5) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. After the publication of the Ranked List the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.
