The candidates who have scored **32 (Thirty Two)** marks and above are included in **Part I** and candidates who have scored **50.75 (Fifty (point) Seven Five)** marks and above are included in **Part II** of the Short List.

Note :- (4) Candidates included in the Short List should be present in person and produce the original documents for One Time Verification and Interview. **Date, Time and Venue of OTR Verification and Interview will be published shortly.**

Note :- (5) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note :- (6) According to the existing procedure, Revaluation and Rechecking of answer scripts of Descriptive Test are not allowed. Detailed instructions will be published in the Ranked List notification to be published for the post.

Note :- (7) Scanned image of Tabulation sheet and answer scripts of the Descriptive Test held on 09-10-2023 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
