#### **CHAPTER-I**

#### CONSTITUTIONAL POSITION OF THE COMMISSION

The Public Service Commission is a body constituted under the provisions from Article 315 to 323 of the Constitution of India. The provisions regarding the Union Public Service Commission and other State Public Service Commission have been laid down in Chapter II of part XIV of the Constitution.

The Constitution empowers the Commission to deal with the matters relating to the services and enable them to discharge their duties in a fair and impartial manner free from influence from any quarter. The Chairman and Members of the Commission are appointed by the Governor of the State .The Composition of the Commission is such that as nearly as one half of members of it shall be persons who on the date of their appointment have at least 10 years of service under the Government. The Chairman or any other member of the Commission can hold office for a period of six years or till he attains the age of 62 years whichever is earlier. On the expiry of the term, the Chairman or any other Member is ineligible for re-appointment under the Central or the State Government. But a Member of the Commission may be appointed as the Chairman of the Commission or as the Member of Union Public Service Commission for another term. The Chairman or any other Member of the Commission can be removed from the office only by the President of India in accordance with the procedure laid down in the Constitution. The conditions of service of the Chairman or a Member once appointed cannot be varied to his disadvantage. The expenses connected with the Public Service Commission are not voted but are charged on the Consolidated Fund of State.

#### **CHAPTER - II**

#### **COMPOSITION OF THE KERALA PUBLIC SERVICE COMMISSION**

In accordance with the provisions contained under Regulation 3 of the Kerala Public Service Commission (Composition and Conditions of Service of Members and Staff) Regulations 1957, made by the Governor under Article 318 of the Constitution of India, as amended from time to time, the Commission shall consist of a Chairman and 20 Members.

# CHAPTER – III FUNCTIONS OF THE COMMISSION

The functions of the Kerala Public Service Commission are as laid down in Article 320 of the Constitution of India with regard to the services of the State. They are:

- i) To conduct examinations for appointment to various services of the State,
- ii) To advise Government on
  - a) Matters relating to method of recruitment to the various services of the State,
  - b) The principles to be followed in making appointments to the services of the State and in making promotion and transfers from one service to another and on the suitability of candidates for such appointments, promotions and transfers,
  - c) All disciplinary matters affecting Government Servants,
  - d) Claims of reimbursement of legal expenses incurred by the Government servants in defending legal proceedings instituted against them for act done or purported to be done in the execution of their duty,
  - e) Claims for award of injury pension to Govt. servants and
  - f) Any other matter referred to them by the Government.

The Commission is also discharging the additional functions entrusted to them by the State Legislature under Article 321 of the constitution of India as regards the services and posts in Government owned Companies, Corporations, Boards and bodies constituted by law and of the Local Bodies in the State. Later, additional functions in respect of certain Co-operative institutions have been brought under the purview of the Commission.

The matters on which the Commission need not be consulted have been specified in the Kerala Public Service Commission (Consultation) Regulations, 1957 made under the proviso to Article 320(3) of the Constitution of India.

# CHAPTER - IV STAFF AND ACCOMMODATION STAFF OF THE KERALA PUBLIC SERVICE COMMISSION

The total members of staff of the Commission during the year under report were **1,644**. The **8 (eight)** staff members working in Vigilance Cell were on deputation from the Department of Police and due to the non availability of Librarian Gr.I from Common Pool category after repeated requests to Government the Commission, vide Decision No.28 dated: 26.11.2012 decided to appoint Librarian Gr.I on contract basis and appointed Sri.Syam Krishnan.R., as Librarian Gr.I with effect from the FN of 02.09.2013 vide Order No.Estt.II(2)2129/2008/GW dated: 02.09.2013 of the Secretary, Kerala Public Service Commission. In exercise of the powers conferred on the Commission under Clause 12 – Sub Clause 2 of the Kerala Public Service Commission (Composition and Conditions of Service of Members and Staff) Regulation 1957, 25 posts in various categories were created for a period of 6 months in two spells with effect from 01.04.2015 and a further period of 6 months with effect from 01.10.2015. The details of Staff of the Commission during the period under report are given in Appendix I.

#### **TEMPORARY STAFF APPOINTED**

Under Regulation 12 (2) of the Kerala Public Service Commission (Composition and Conditions of Service of Members and Staff) Regulation 1957, the Commission have created 13 posts as per Order No.Estt.II (3) 32900/08/GW dated 30-03-2015 for a period of six months from 01.04.2015 and 12 posts for a period of six months with effect from 01.10.2015 as per order No.Estt.II (3) 32900/08/GW dated 16-09-2015.

#### VIGILANCE AND SECURITY OFFICER

The Vigilance and Security Officer of KPSC, Sri.Sabu.P.S, Superintendent of Police (Non-IPS) has relieved from duty on 18.09.2015 AN vide order No. Estt-II(1)12000/2013/GW(2) Dated 17.09.2015. Now the post is vacant. 90 cases were pending at the beginning of the year, 21 files were received and 20 reports were submitted during

the period under report. 91 cases are pending with the Vigilance Wing at the close of the year.

#### LEGAL RETAINER

Sri. P.C. Sasidharan, Advocate, High Court of Kerala is continuing as the Legal Retainer to Kerala Public Service Commission since 01.03.2011, he is authorised to conduct cases before the Hon. High Court and Sri C A Majeed, Advocate is also posted as Legal Retainer to Kerala Public Service Commission w.e.f 01.04.2014 and he is entrusted to appear before the Kerala Administrative Tribunal on behalf of the Commission.

#### ACCOMMODATION

The Kerala Public Service Commission have District Offices in all Districts and three Regional Offices at Kollam, Ernakulam and Kozhikode. The Head Office and Thiruvananthapuram District office of the Commission are situated at Thulasi Hill, Pattom, Thiruvananthapuram. In all there are 18 offices including the Head Office. The District Offices of Palakkad, Malappuram, Kozhikode and Kannur are accommodated in the respective Civil Stations of the Government of Kerala. The Regional Office, Kozhikode is also situated in the Civil Station, Kozhikode. The District Offices in Alappuzha, Pathanamthitta, Thrissur, Wayanad and Kasargod are functioning in rented buildings. The District Office Kottayam is functioning in Commission's own building. The Regional Office and District Office Ernakulam are functioning in GCDA building at Ernakulam with effect from 21.01.2013. The District Office, Idukki is functioning in the Kerala State Housing Board Building at Kattappana. The District Office and Regional Office at Kollam are housed in Corporation Building. The official residence of the Chairman at Thiruvananthapuram is also a rented building.

#### **GUEST HOUSE**

Kerala Public Service Commission acquired a Guest House on rental basis located at Vrindavan Gardens, Pattom Thiruvananthapuram owned by Kerala State Housing Board, is established to provide boarding facilities to Guests and to Experts who are invited by the Commission to assist in interviews, Practical Tests and evaluation of answerscripts.

# CHAPTER – V

#### RESEARCH AND ANALYSIS WING, ONLINE EXAMINATION CENTRES, CALL CENTRE, COMPUTERISED ATTENDANCE MANAGEMENT SYSTEM, AA&VW, WEBSITE, PUBLIC RELATIONS UNIT, ENQUIRY, INFORMATION DISSEMINATION SECTIONS AND LIBRARY

#### **RESEARCH AND ANALYSIS WING**

The main function of Research & Analysis Wing is co-ordination, planning and monitoring of selection process with a view to improving the quality of work and minimising delay in the different stages of recruitment, by conducting comprehensive studies and imparting in-service training to the members of the staff. Purchase and maintenance of computers and other allied equipments are also done through the R&A wing.

Notifications received from various recruitment sections are consolidated and steps for publishing them in the Gazette are done in the section. Correspondence with other Public Service Commissions and Union Public Service Commission are done by Research & Analysis Wing. Agenda for the sitting of the Commission is also prepared in this wing.

Details regarding Legislature Assembly interpellation are collected and furnished to the Government from Research & Analysis Wing for submission before the Assembly. During the year under report **241** questions were received from the Government and reply were given in **241** cases. The compilation of the Annual Report of the Commission and furnishing of statistical data relating to different stages of selection are also being prepared in the Wing.

The PSC Manual is revised by incorporating the modified procedures in tune with the Commissions policy of utilizing IT enabled services to make the recruitment process faster, accurate and more transparent.

The Technical committee constituted for the supervision of computerization in the office of the commission has been convened five times on 25/04/15, 08/07/15, 09/10/15, 30/12/15 and 12/01/16 during the report 2015-2016. An amount of Rs.3,50,00,000/- (Rupees Three Crores Fifty lakhs only) was allotted during the financial year 2015-2016 in the plan fund . The entire amount of Rs..3,50,00,000/- (Rupees Three Crores Fifty lakhs only) has been spent for the up-gradation of modernization by way of purchasing hardware, other computer peripherals, payment of AMC charges and various training

programmes etc.

#### TRAINING PROGRAMMES

Kerala Public Service Commission have organised various training programme for the staff with a view to fortify their efficiency to perform duties more effectively. The various in house and external trainings given in the year 2015 – 2016 are listed below:

# Statement showing the details of work done by the Kerala PSC (R & A Wing)in the report year

# 1. <u>E-payment facility for Departmental Tests</u>

Online payment for Departmental Tests exam fee and fee for certificates included in the Departmental Test Wing Registration System – DTRS software and is in use.

#### 2. Contribution to PSC Bulletin

Introduced PSC Bulltein Subscription Management System for Online payment of Bulletin through One-time Registration Software.

#### 3. Question Banks

Question Bank module completed. Its linking with online exam software is in progress.

### 4. <u>Automatic allocation of test centres only for those downloading Admn.Tkt.</u>

Dynamic allocation facility for allocating exam centres and register numbers to those candidates who only download the admission ticket for exam is ready for implementation so as to curtail extra cost incurred by absentees.

#### 5. <u>E-vacancy Software</u>

Departments can report their vacancy directly to PSC by online facility using their web application. This system is in use.

#### 6. <u>Smruthy Software</u>

Registration and login for serving & retired members of Kerala PSC. They can watch their profile to know the present status of medical reimbursement claims preferred.

#### 7. Thulasi Software – Modified interface

In the report year 2015-16, we are used a modified version of Thulasi Software for One –Time Registration and almost all the technical work of Kerala Public Service Commission and now it is also under modification.

#### 8. KPSC Petitions Management System

This System facilitates to register the petitions received from candidates and issue printed receipts.

Status : The System has been implemented successfully and is in use.

#### 9. eResultPro (Elecronic Result Process System)

System for uploading valuation data, entering cutoff marks and preparing Probability List/Shortlist and Ranked list. This system is in use and under modifications.

#### 10. <u>e-Advice pro</u>

System receives ranked list and rotation data and prepares advise letters for both candidates and Department(Software Development completed).

#### **ONLINE EXAMINATION CENTRES**

Kerala Public Service Commission had already been set up and functioned 3 (three) Online Examination Centres at Thiruvananthapuram, Pathanamthitta and Eranakulam respectively. Now at present, for the candidates in Malabar area of Kerala a new and its 4<sup>th</sup> Online Examination Centre at Kozhikode Civil Station – A Block set up completed with the capacity to hold 320 candidates at a time and 640 candidates can be examined with single pattern of question being built up and is expected to be completed by October 2016.

#### CALL CENTRE

The Call Centre functions from 10.15 am to 5.15 pm without break on all working days. About 2,12,000 calls were received during the year under report at the call centre.

#### COMPUTERIZED ATTENDANCE MANAGEMENT

Attendance Management Section has been established under Research and Analysis Wing to monitor the computerized attendance management in the offices of the KPSC .

#### APPOINTMENT AUDIT AND VERIFICATION WING


Appointment audit and verification wing was started with effect from 1.9.2011 as per GO(P)41/2010 P&ARD dated 14/12/10. A total no.of 4,612 applications were received during the year and total no.of 5,241cases have been verified (including the pending applications of last year)during the year under report. And 1,028 applications are pending for verification as on 31/03/2016.

#### **PUBLIC RELATIONS UNIT FUNCTIONS**

The Public Relations Unit functions as an effective link between the Kerala Public Service Commission and the Public. The sustained effort of the Unit is instrumental in the maintenance of better rapport and good relations between the Commission and various media organizations including Press, All India Radio, Doordarshan, other TV Channels, Local Networks and Websites.

#### PERFORMANCE

Information intended for the Public is regularly being supplied by means of press releases and public statements. The dates of Examination and Interviews of the Commission are given due publicity through News Papers, All India Radio, Doordarshan, PSC Bulletin, other TV Channels and through Website of KPSC .

All the media organizations have extended wholehearted co-operation and rendered worthy assistance in giving due publicity to these matters. The opinions, suggestions, criticisms and complaints made by the general public, and the views of press and public leaders are brought to the notice of the Commission in time by the Public Relations Unit. Whenever necessary, detailed public statements, clarifications, etc are also issued by the Commission through Public Relations Unit. The Public Relations Unit functions also as an information centre. During the year 2015-2016 total 197 press releases were issued.

#### **ENQUIRY WING**

The Enquiry wing in the Head Office of the Commission works continuosly from 8 am to 6 pm in two sessions on all working days. It consists of an Enquiry Officer, five Assistants. The Enquiry wing is rendering remarkable service to clarify the doubts of hundreds of candidates approaching the Commission in person.

#### PUBLICATION OF PSC BULLETIN

The PSC Bulletin, the official publication of the Commission, restarted publication with the release of the issue dated 01.06.1997. Ever since the restart of the publication, the PSC Bulletin is being published regularly as a fortnightly(24 issues in one year) on the 1<sup>st</sup> and 15<sup>th</sup> of every month without break.

Information oriented articles on contemporary issues and current affairs beneficial to job seeking youth are added along with the regular columns such as Clarification of doubts, Advice for Appointment, Ranked Lists, Short Lists, Interview Programme, Examination Schedule, Previous Questions and Revised Answer Key of Various Tests conducted by the Commission. Articles relating to Science and Culture and model questions on general awareness, numerical aptitude, mental ability etc. are published. The details of the Gazette Notifications inviting applications for selection to various posts form the main feature of the PSC Bulletin.

24 issues of PSC Bulletin have been published during the period under report. 36 new agents have been appointed to ensure the proper distribution of bulletin. Circulation of PSC bulletin during the period is 33,000. Promoters and Talukwise sales organisers have been engaged for speedy and prompt distribution of the bulletin.

#### INFORMATION DISSEMINATION SECTIONS

Information Dissemination Section (appeal) has been created to deal with the appeals received under Right to Information Act 2005. It also deals with Grievance petitions received from the candidates. The cell is functioning under the control of a Joint Secretary who is the first appellate authority under the provisions of Right to Information Act . There are 18 State Public Information Officers and 19 Assistant Public Information Officers and one Appellate Authority designated in KPSC

The Commission have decided to re-established the centralised system under one SPIO in the rank of under secretary with two sections with effect from 01.03.2014.

#### LIBRARY

The Kerala Public Service Commission Office Library functions as a reference-cumlending library; and its membership is restricted to the Members and Staff of the Commission. Besides the normal functions of the library, the following additional items of work are also done in the library.

1. Preparation of Index of question papers of previous selective tests and departmental tests

- 2. for future reference.
- 3. Preparation of index of the Notifications published by the Commission in the Kerala Government Gazette.
- 4. Classification and Cataloguing of new books received in the library.
- 5. Ready reference service.

The Library Committee convened on 04.02.2013 &25.03.2013 resolved to provide new books and periodicals by obtaining suggestions from Hon'ble Chairman, Members and staff of Public Service Commission. It has been modified the internal structure of the library and library hall. New software'Koha',has been installed for smooth functioning of the Library.

#### **RECEIPT AND EXPENDITURE**

The receipt of the Commission by way of remittance of fee into the Treasuries for admission to Departmental Tests, fee for Certificates and Attendance Certificates of Departmental Tests and Other Miscellaneous receipt etc. including receipt on account of Court Fee Stamps, Indian Postal Orders, and sale of PSC Bulletin amounts to **Rs 2,34,19,094/-.** The total receipt for the previous year was **Rs.2,29,61,636/-**. The total Audit Estimate (sanctioned) for the period was Rs. **1,30,15,58,000/-.** and the expenditure comes to **Rs.1,29,89,00,482/-.** as against **Rs.1,25,46,12,348/-i**n the previous year. 

#### **VOLUME OF CORRESPONDENCE**

The total number of communications received from the Government and the Heads of various Departments, Companies, Corporations, Boards, Local Authorities, Co-operative Institutions etc. and other miscellaneous petitions during the year under report was **1,52,427** of which **67,485** were received in the Head Office, **7,499** were received in the Regional Offices of the Commission and **77,443** were received in the District Offices . **3,423** communications were received from the Government, **49,921** from the Heads of various Departments, Companies, Corporations, Boards, Local Authorities Co-operative Institutions etc. While **76,448** communications were received by way of petitions and other miscellaneous references.

#### **COMMUNICATIONS SENT**

During the year under report a total number of **1,22,722** communications were sent to the Government, Heads of various departments, Companies, Corporations, Boards, Local Authorities and Co-operative Institutions of which **10,013** were sent from the Head Office and **23,982** from the Regional Offices and 88727 from the District Offices of the Commission. **2,495** communications were sent to Government and **33,104** to the Heads of various departments, Companies, Corporations, Boards, Local Authorities and Co-operative Institutions. A total of **92,378** communications were sent to the candidates by way of admission Tickets, Rejection Memos etc. of which **12,346** were sent from the head office and **20,356** from the Regional offices and **59,676** from the District Offices of the Commission. **9,607** communications were sent on miscellaneous correspondence of which 561 were sent from the Head Office and **7,812** from the Regional Offices and District Offices of the Commission. 


#### STATISTICAL REPRESENTATION OF CANDIDATES ADMITTED FOR WRITTEN TEST DURING THE LAST TEN YEARS

### CHAPTER-IX

# RECRUITMENT - COMPANIES / CORPORATIONS / BOARDS / LOCAL AUTHORITIES

Under Article 321 of the Constitution of India, an Act made by the Legislature of the State may provide for the exercise of additional functions by the Commission in respect of the Service of the Companies, Corporations and Boards & Local Authorities by the Kerala Public Service Commission Additional Functions Acts enacted by the Legislature from time to time. Selection process to various posts to these institutions are carried on in Corporation Wing which functions under a Joint Secretary. At present there are **103** Companies, Corporations, Boards and Local Authorities for which recruitment of candidates is made through Kerala Public Service Commission.

During the reporting year **59** posts were notified for selection to various posts in Companies, Corporations, Boards and Local Authorities for which **9,20,220** applications were received. **4,871** candidates were advised to these bodies.

#### CHAPTER – X

#### **RECRUITMENT – CO-OPERATIVE SECTOR**

The Kerala Public Service Commission (Additional Functions as Respects Certain Societies) Act has come into force as per Act 5/96 empowering the Commission to exercise additional functions in regard to the recruitment of employees in 15 Apex Co-operative Societies and District Co-operative Banks. The rules under the Act viz, The Kerala Public Service Commission (Consultation by Committee of Co-operative Society) Rules, 1998 were issued on 10.03.1998. Selection process to various posts to these bodies are carried out in Co-operative Sector Section, which functions under a Joint Secretary Selection process for 14 District Co-operative Banks, 15 Apex Co-operative Societies and 3 other societies are left under the purview of the Commission.

During the reporting year **110** posts were notified for selection to various posts in Cooperative sector for which **64,185** applications were received and also **385** candidates were advised by the commission.

#### CHAPTER – XI

#### SPECIAL RECRUITMENT FOR SCHEDULED CASTES AND SCHEDULED TRIBES

In accordance with the policy of the Government and as provided for in Rule 17 A of the Kerala State and Subordinate Service Rules, 1958 the Commission continued the Special Recruitment of Scheduled Caste/Scheduled Tribe candidates in respect of vacancies reported by the appointing authorities.







# CHAPTER – XIII

# **REGIONAL OFFICES**

Regional Offices at Kollam, Ernakulam and Kozhikode are headed by a Regional Officer in the cadre of a Joint Secretary and assisted by one Under Secretary and three Section Officers. An Enquiry Officer supervises the Enquiry section. Fair Copy Section is supervised by an Office Superintendent.

The work relating to the selections to posts in the Kerala State Rural Development Board and Development Authorities in Thrissur and Northern Districts, LGS in various company/board corporations, Vocational instructors in VHSC and certain posts of KSFE are allotted to the Regional Office, Kozhikode. The work relating to various posts in the Municipal Common Service and Greater Cochin Development Authority, LSGD, some posts under PWD, various company/corporation,Forest Industries Travancore LTD,etc. are allotted to Regional Office, Ernakulam. The posts relating to Thiruvananthapuram Development Authority, Idukki Development Authority and also relating to any other Developmental Authorities that are likely to fall within the region of Kollam, certain posts in Fire and rescue service Dept. Commpany/ Corporation,KFC,KSRTC etc are allotted to the Regional Office, Kollam.

# CHAPTER – XIV

# **DISTRICT OFFICES**

The Kerala Public Service Commission has District Office in all the 14 Districts. All of them, except that in Idukki, continued to function at the Head Quarters of the respective district The District Office at Idukki is functioning at Kattappana.

#### **ORGANISATIONAL SET UP**

Each District Office is headed by a District Officer in the cadre of Deputy Secretary. There are three Under Secretaries in the District Office of the KPSC, Thiruvananthapuram. and two Under Secretaries each in the remaining District Offices. District Offices of Kollam, Thrissur, Kozhikode, Alapuzha, Palakkad, Kottayam have six sections supervised by 6 Section Officers. In other Districts viz. Kasargod, Wayanad, Idukki, Pathanamthitta there are 5 sections supervised by five Section Officers. In the District Office, Thiruvananthapuram there are 9 sections headed by 9 Section Officers and in District Office Ernakulam, Kannur and Malappuram there are 7 sections each headed by seven Section Officers. There is one Enquiry Counter at each District Office to furnish information to the Public.


# **DISCIPLINARY CASES**

# CHAPTER – XXIV

# COMMITTEE FOR REDRESSAL OF COMPLAINTS OF WOMEN EMPLOYEES

Based on the Supreme Court judgement dated 13.08.1997, the Government have directed PSC to set up a complaint redressal mechanism and to constitute a Committee for the time bound redressal of complaints of women employees in accordance with the guidelines laid down by the Supreme Court. Accordingly the Commission have constituted a Committee with effect from 25.04.2001 and the same is functioning effectively in this office in tune with the guidelines of the Apex Court. The Committee comprises the following members as on 31.03.2016.

During the reporting year the Committee was convened four times on 20/04/2015, 04/05/2015, 06/06/2015 and 25/06/2015. Three complaints were received from the women employees during the year under report. And two of them are disposed. One case is pending.

# **CHAPTER – XXV**

# DEVIATION FROM THE ADVICE OF THE KERALA PUBLIC SERVICE COMMISSION

1. Sri.A, Ex P C Q of the State Crime Records Bureau was removed from service from the date of his unauthorized absence by the Inspector General of Police, SCRB and his appeal was rejected by the State Police Chief . Against that order he submitted review petition before the Government and the same was rejected by the Government. Then he submitted mercy petition before the Government and

Government took a tentative decision on humanitarian grounds to reduce the punishment of removal from service to compulsory retirement so as to enable the review petitioner to get pensionary benefits and sought the advice of the Commission. Hon'ble Commission disagreed to the tentative decision of the Government and advised the Government accordingly. Government have once again put forward the proposal to reduce the punishment of removal from service to compulsory retirement The Commission resolved to stick to their earlier decision and disagreed to the tentative decision of the Government accordingly. But the Government vide GO(MS)No.173/ 2015/Home dated 18/08/2015 has decided to finalize the mercy petition submitted by him by reducing the punishment of removal from service imposed on him as compulsory retirement, so as to enable him to get pensionary benefits, overruling the advise tendered by Public Service Commission.

# 2. <u>Kerala State Film Development Corporation Limited - Regularisation of provisional</u> <u>Employees</u>

Government have forwarded a proposal of the Managing Director, Kerala State Film Development Corporation to regularise the service of daily waged employees who were working for more than 10 years in the Corporation. The commission disagreed with proposal and the decision was intimated to the Government informing not to regularise the appointments as most of the provisionally recruited employees were unqualified.

However the Government vide G.O(Ms)29/2015/CAD dated 03.09.2015, have regularised the service of 53 provisional employees in KSFDC and as per G.O(Ms)38/2015/CAD dated 12.11.2015, Government have regularised the service of 27 daily waged employees

**3.** Disciplinary action had been taken by the Government against Sri."A', who was the Lift Operator in GAD for his unauthorised absence by impossing compulsory retirement and issued Orders accordingly. Against this order the imcumbent submitted a representation before the

Chief Minister citing that he is endowed with physical disability and hence the displinary action taken against him to be withdrawn. Considering the representation and taking consideration of the compassionate family condition, the Government have taken a provisional decision to reinstate him in service and advice was sought from the Commission. The Commission gave advice against the proposal of the Government to reinstate a person who was given compulsory retirement as a punishment for his unauthorised absence. But considering the compassionate family conditions again the matter was forwarded to the Commission for re-examining its earlier advice. But the Commission gave advice against the proposal for reinstate him in service citing the reason that no sufficient reason is seen in the letter from the Government to re-think the earlier decision of the Commission. But as per the Govt. Order No.GO(Rt) No.3715/15/GAD dated 19/05/2015, the Govt have overruled the advice of the Commission and reinstated him in service.

- 4. The Commission have disagreed with the proposal of the Government regarding reinstatement of Sri.Vishnuprakash who had been dismissed from service. But overruling the advice of the Commission the Government have issued Orders GO(Ms)No.120/15/Home dated 11/06/2015 and reinstated in the Police Service.
- 5. In the issue of 25% quota of teaching posts in Higher Secondary Education Department from the cadre of HSA, LPSA, Lab Assistant, Ministerial staff, the Commission have proposed to amend the Special rules. But overruling the advice of the Commission, the Govt. have issued executive orders by GO(Ms)No.296/15/Gen.Edn.dtd01/12/2015.
- 6. The Commission have disagreed with the proposal of the Govt. regarding regular appointment of Sri.T.R.Shylesh Kumar who was a daily wage Pump Operator under

Medical education Department in T D College, Alappuzha. But overruling the advice of the Commission the Government have given regular appointment to Sri.shylesh Kumar in the above post as per GO(Ms)No.286/2015/H&FWD dtd.08/12/15.

- 7 The Commission have disagreed with the proposal of the Government to appoint Sri.V.P.Shaji as Watchman-Cum-Valve Operator on regular basis under humanitarian consideration, who was working as Watchman on provisional basis in Kerala Water Authority (through Employment Exchange). But the Government have overruled the advice of the Commission and issued GO(Ms)No.107/15/WRD dated 27/11/2015 which he had been appointed permanently.
- 8 Even though the Joining time had been extended to Sri.Dhanesh, who was advised to KAP V Battalion as Police Constable, he had not joined and the vacancy was reported as NJD. Considering the request of Sri.Dhanesh, the Government sought the advice of the Commission. But the Commission disagreed with the proposal, the Government overruled the decision and issued GO(Ms)No.90/2016/Home by which Sri.Dhanesh was allowed to join as Police Constable.
- 9 The Government have sought the advice of the Commission regarding the reinstatement of Sri.Sreekanth G R who had resigned from service while he was working as LD Clerk in Marancherry ITI under the Industrial Training Department. The Commission disagreed with the above proposal but the Government overruled the advice of the Commission and as per GO(Rt)894/15/Labour dated 07/07/2015 reinstated him in service.

# CHAPTER – XXVI

# COMPARATIVE SUMMARY OF WORK DONE BY KERALA PUBLIC SERVICE COMMISSION

At the initial stage the workload of the Commission was limited. As years passed a remarkable change has occurred in the growth of literacy, as a result number of well-educated youth has also increased in the State. Accordingly the number of job seekers has

become enormous. Applications received for various posts began to be heaped up in all the offices of the Commission. Requests for increasing the strength of Staff had been placed to the government on several occasions and the Government have accepted the same to a certain extent. Thus, the total strength of the staff reached up to 1644 during the reporting year 2015-2016 Since the manpower was found insufficient to cope with the enormously increasing workload the Commission resorted to mechanization with effect from 2002, so as to achieve simplification, accuracy and speed in the selection process. A tabular form of comparative study of work done for the last ten reporting years (2006-2007 to 2015-2016 and five years comparison of work done (2006-2007 to 2010-2011 & 2011-2012 to 2015-2016) are shown in the succeeding pages.
