The following is the list of candidates for selection to the post of **FOREST DRIVER (FIRST NCA E/T/B)** on **Rs. 19,000-43,600/- (PR)** in **FOREST DEPARTMENT IN MALAPPURAM DISTRICT (CAT No. 700/2021)**, arranged in the order of merit on the basis of the Common OMR Test held on **29.11.2023**, Physical Measurement & Physical Efficiency Test and Practical Test (Driving Test - T Test and Road Test). This Ranked List is brought into force with effect from **06.05.2025** and will be valid until the candidates are advised and appointed against the vacancies notified due to the paucity of candidates belonging to Ezhava/Thiyya/Billava community during the currency of the Mother Ranked List published on 08.06.2021 (Cat No. 120/2017).

NOTE (1):- Since a common OMR Test with common candidates was conducted for this post , the marks awarded to candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be on the basis of the common test.

NOTE (2) :- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for through their One Time Registration profile from the Commission's Official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five Only). The fee can be remitted by e-payment through the portal. Application submitted in any other manner will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the Website of the Commission ie. on or before **27.05.2025**.

NOTE (3) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs.335/- (Rupees Three Hundred and Thirty Five Only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission ie. on or before **27.05.2025**. Application submitted in any other manner will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued.

NOTE (4): - The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalized on the basis of the common test.

NOTE (5) :- The entries put in column (9) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents. The candidates whose Communities have not been correctly noted in the Ranked List as proved by them in their Application should intimate the fact to the District Officer, Kerala Public Service Commission, District Office, Civil Station (P.O), Malappuram- 676505 within one month from the date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (6) :- The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission addressed to the District Officer, Kerala Public Service Commission, District Office Malappuram, 676505 either directly or by post. The format is available in the Official website of the Commission. Those who do not submit the relinquishment application in the format prescribed by the Commission, will not be honoured under any circumstances. The request for relinquishment should be duly attested by a Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested Copy of an ID Proof bearing Photograph as enlisted in the General Conditions. The request for relinquishment, along with the original Notarized affidavit and self attested copy of an ID proof received within 15 days from the date of uploading of Ranked List in the Official website of the Commission (ie. on or before **27.05.2025**.) will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he is to be advised.

NOTE (7) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of the last Ranked list included in the Common OMR Test held on **29.11.2023**.
