The following is the list of candidates for selection to the post of **Forest Driver(First NCA LC/AI) (Category No. 703/2021)** on **Rs.19,000-43,600/-(PR)** in **Forest Department in Palakkad District**, on the basis of **OMR Test held on 29.11.2023** , **Physical Measurement and Physical Efficiency Test held on 05.07.2024, 10.10.2024, 14.10.2024, 17.10.2024 ,21.10.2024 and Practical Test held on 04/03/2025 and 05/03/2025** arranged in the order of merit. This Ranked List is brought into force with effect from **02.05.2025** and will be valid until the candidates are advised and appointed against the vacancies earmarked for the above community but remain unfilled due to the paucity of candidates during the currency of mother Ranked List published on 08.06.2021 for Category.No.120/2017.

NOTE (1) :- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for through their One Time Registration profile from the official Website of the Commission www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five Only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner (ie; via e mail / Tappal /Direct) will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which the Ranked List uploaded in the official Website of the Commission ie on or before **26.05.2025**. Applications for rechecking received after the stipulated time will not be considered and fees once remitted will not be returned. Applications submitted through e-mail / by post / in person will not be considered.

NOTE (2) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official Website of the Commission www.keralapsc.gov.in by remitting prescribed Fee of Rs. 335/- (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Ranked List uploaded in the official Website of the Commission ie on or before **26.05.2025**. Applications submitted in any other manner (e mail/ by post / in person) will not be considered. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued.

NOTE (3) :- The entries put in column (5) are based on the Communities specified by the candidate in their application forms and proved by them with necessary documents. The candidate whose Communities have not been correctly noted in the Ranked List as proved by them in their application should intimate the fact to the District Officer, Kerala Public Service Commission, District Office, Palakkad 678001 within one month from the Date of publication of the Ranked List to get the benefit of Reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the Ranked List.

NOTE (4) :- The candidate who wish to relinquish their claim for advice from the Ranked list shall submit an application in the format prescribed by the commission to The District Officer, Kerala Public Service Commission, District Office ,Palakkad - 678001. The format is available in the official Website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the prescribed format will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE (5) :- Since a common OMR Test with common candidates was conducted for this post, the marks awarded to candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test. The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of OMR answer script will be issued only after the publication of the Ranked Lists to be finalized on the basis of the common test for each post.

NOTE (6) :- The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of last Ranked list included in the common OMR test held on **29.11.2023**
