Note :- (6) Copy of answer scripts of the OMR Test held on **12/02/2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer script is invalidated for this post vide Notification No: ER16-3/3/2025-KPSC dated 28.03.2025

Note :- (7) Candidates belonging Other Backward Classes included in this Short list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahildar and candidates belonging to Economically Weaker Section are required to produce EWSC Certificate vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the concerned authority along with other documents at the time of One Time Verification
