NOTE (1):- For Online Examination rechecking and revaluation are not allowed. Candidates who wish to obtain aprint out of their Answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs. 335/(Rupees three hundred and thirty five) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for print out of answer sheet will be allowed to candidates witheffect from the date on which the Ranked List is uploaded in the website of the Commission (ie on or before 20.02.2025). Application submitted in anyother manner (i.e. via email/Tappal/Direct) will not be considered. A copy of the answer sheet will be issued only once to a candidate.Printout of the answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for printout of the answer sheet which is not their own,and legal proceedings will be initiated against those who do so. Printout of the answer sheet will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

The request for relinquishment, along with the original of notarized affidavit and self attested copy of an ID proof received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of the Ranked List. After the publication of the Ranked List the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.
