Note :- (2) The Short list has been prepared by including the number of candidates who have secured topmost marks in the OMR Test held on 20/12/2024 , based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage.

Note :- (3) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Short list without further notice.

Note :- (4) **20(Twenty)** candidates who have secured top most marks in the OMR Test are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **48.33 (forty eight (point) three three)** .For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economicaly Weaker Section, necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (5) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be intimated in due course**

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (7) Candidates included in the Short List who are eligible for reservation for Other Backward Classes are required to produce Non Creamy Layer Certificate as per G.O(P)No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district project in the format prescribed in G.O(Rt) No 3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue Authority in the format prescribed in Kerala (Scheduled Castes and Scheduled Tribes) Regulation of issue of Community Certificates Rules, 2002 and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the revenue Authority along with other documents at the time of OTR verification of original documents.

Note :- (8) Copy of answer scripts of the OMR Test held on **20-12-2024** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No Answer script is invalidated for this post vide Invalidation Notification number ER9-3/1/2025-KPSC dated 20 /06/2025
