NOTE (1) :- For Online examination rechecking and revaluation are not allowed but printout of answer sheet will be issued to those who apply for it by remitting the prescribed fee. Candidates who wish to obtain a printout of their answer sheets relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in, by remitting the prescribed fee of **Rs.335 (Rupees Three Hundred And Thirty Five Only)** via e-payment mode available in the portal. A period of **15 (Fifteen) days** time to apply for printout of answer sheets will be allowed to candidates with effect from the date on which the Ranked list is uploaded in the website of the Commission.(i.e. on or before **24.07.2025**). Applications submitted in any other manner (i.e. Via email/tappal/direct) will not be considered. A copy of an answer sheet will be issued only once to a candidate.

After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of vacancy, based on which he/she is to be advised.
