### NOTIFICATION

The following is the list of candidates for selection to the post of **Lower Division Typist (By Transfer appointment from LGS and Ministerial Employees working in Kerala Water Authority)** on Rs. 27,200-73,600/ in Kerala Water Authority (Cat No.250/2023), found suitable by the Commission and arranged in the order of merit on the basis of Common OMR Test held on 30/08/2024. This Ranked List is brought into force with effect from **26.06.2025**.

**Candidates who have secured Forty percent (40%) marks and above in the OMR test are included in the list and there is no candidate to be appended from the previous Ranked List for the post.**

**NOTE (1):-** The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years which ever is earlier. Rules of Reservation and Rotation (Rules 14 to 17 of KS & SSR) shall not be applicable in the case of By Transfer appointment and candidates whose names are arranged in the order of merit in the Ranked List shall be advised against vacancies reported to the Commission during the pendency of the Ranked List. As the advice for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the Ranked List will secure appointment. The candidates remaining in the Ranked List at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the Ranked List.

**NOTE (2):-** In case candidate included in this Ranked List could not secure appointment before the expiry of the Ranked List, the name of the candidate will be included at the top of the new Ranked List of the low paid employees drawn up by the Commission subsequently in the same order and they will be advised for appointment accordingly vide G.O.(P) No. 39/89/ P & ARD dated 08.12.1989.

**NOTE (3):**According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply through their One Time Registration profile from the Commission's official website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) by remitting the prescribed fee of **Rs.85/- (Rupees Eighty Five only)**. The fee can be remitted by e- payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date on which the Ranked List is uploaded in the website of the Commission (ie, on or before **17.07.2025**). The candidates can avail only one chance after the Approval of the Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded. Applications submitted through email/by post/in person will not be considered.

**NOTE (4) :-** Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the Commission's official website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) by remitting the prescribed fee of **Rs. 335/- (Rupees Three Hundred and Thirty Five only)** via e- payment mode available in the portal. A period of 15 (Fifteen ) days time to apply for photocopy of OMR Sheets will be allowed to candidates with effect from the Date on which the Ranked List is uploaded in the website of the Commission. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is **17.07.2025**. Applications received after the prescribed date will not be entertained. Applications submitted through email/by post/in person will not be considered.

**NOTE (5) :-** Candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to THE SECRETARY, KERALA PUBLIC SERVICE COMMISSION, HEAD OFFICE, PATTOM, THIRUVANANTHAPURAM-4. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a Notarized Affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions. The request for relinquishment along with a Notarized Affidavit and a self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of Requisition, based on which he/she is to be advised.

**NOTE (6) :-** Since a common OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in the Ranked List will be published only after the publication of entire Ranked Lists (including NCA notifications) which will be finalised on the basis of the common test. The result of rechecking of OMR answer script will be intimated in due course. But photocopy of OMR script will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

**NOTE (7) :-** The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of last Ranked List included in the common test held on 30/08/2024.
