### **NOTIFICATION**

It is hereby notified that the Part -II (Recruitment by By Transfer) is appended as follows to the Ranked List for selection to the post of Clerk (Cat. No. 504/2023) on Rs. 26,500-60,700/- in Various Departments in Thrissur District, brought into force w.e.f. 01.08.2025. Candidates who have secured forty percent (40%) marks and above in the Objective Type test (OMR valuation) held on 09.10.2024 are included in the list. The list of unadvised candidates remaining in the Part– II of the previous Ranked List is carried over and included at the top of this list.

**Note 1):-** According to the existing procedure, revaluation of Answer script is not allowed. But Answer scripts will be rechecked if the candidates apply through their One Time Registration profile from the Commission's official website [www.Kerala psc.gov. in](http://www.Kerala psc.gov. in) by remitting the prescribed fee of Rs. 85(Rupees Eighty Five only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission ie on or before 15/08/2025.

**Note 2):-**Candidates who wish to obtain a photocopy of their OMR Answer sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration profile from the official website of the Commission, [www.Kerala psc.gov. in](http://www.Kerala psc.gov. in) by remitting the prescribed fee of Rs. 335 (Rupees Three Hundred and Thirty Five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for Photo copy of the OMR sheets will be

allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission ie on or before 15/08/2025. Applications submitted in any other manner will not be considered. A copy of the Answer sheets will be issued only once to a candidate. Copies of OMR sheets invalidated to any defect will not be issued. Please note that in the case of Ranked List of those post for which common examinations were conducted the copy of OMR Answer sheets will be provided only after the publication of all the Ranked Lists of those posts for which the candidate has participated.

**Note 3):-**The candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission addressed to the District Officer, Kerala Public Service Commission, District Office, Thrissur- 680020 either directly or by post. The format is available in the Official website of the Commission. Those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment should be duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a Notarized affidavit and a self attested Copy of an ID Proof bearing Photograph as enlisted in the General conditions. The request for relinquishment along with the original Notarized affidavit and self attested Copy of an ID Proof received within 15 days from the date of uploading of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he is to be advised.

**Note 4):-** When a candidate whose name has been included in more than one Ranked List for the same post in the same department/different Departments finalised on the basis of the very same or any other notification under different methods of recruitment / appointment and for which common advice list is prepared and the said Ranked Lists are operated simultaneously, and when such a candidate is advised by the commission from any one of the aforesaid Ranked Lists, his/her name shall be abrogated from the other Ranked Lists.
