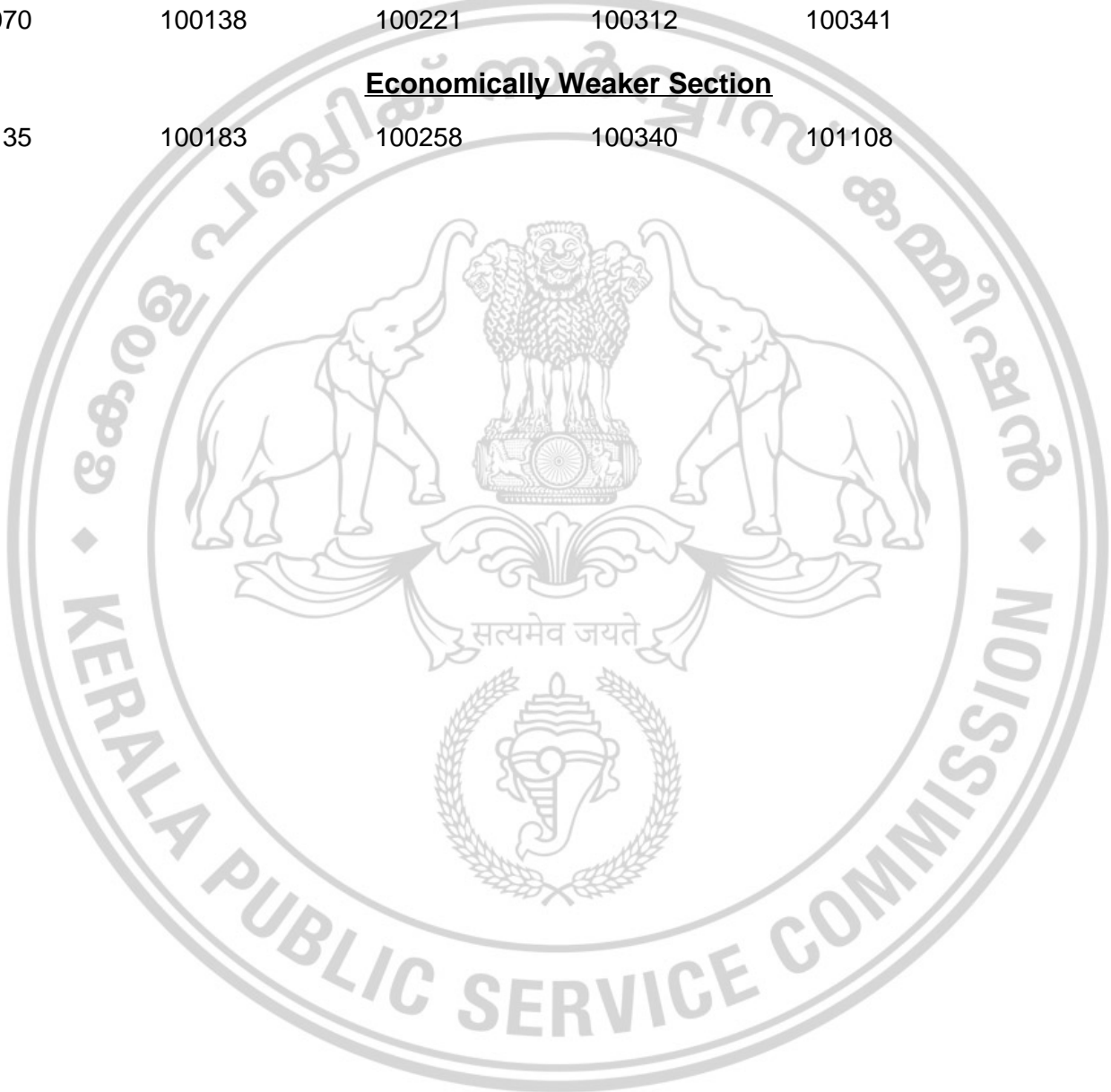

Note :- (2) The short list has been prepared by including the number of candidates who have found provisionally eligible, secured top marks in the Online Test based on the details furnished by the candidate in the application and subsequent claims made will not be entertained at any stage of selection.

Note :- (3) **12 (Twelve)** candidates who have found provisionally eligible, secured top marks in the Online examination are included in the Main List of this Short List. The marks secured by the last candidate in the Main List is **56.00 (Fifty Six)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Other Backward Classes and Economically Weaker Section necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the List shall present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be intimated through SMS & Profile message in due course.**

Note :- (5) According to the existing procedure for Online Examination rechecking and revaluation will not be allowed.

Note :- (6) Candidates included in the Short List who are eligible for reservation for Other Backward Classes are required to produce Non Creamy Layer Certificate (for state employment purpose) obtained from Village Officer, SC candidates are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority (Not below the rank of Tahsildar) and candidates who claim EWS reservation are required to produce EWS Certificate as per vide GO(P)No.3/2024/P&ARD dated 25.04.2024 issued by the Revenue Authority along with other documents at the time of OTR verification of original documents.

Note:- (7) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short list without further notice.

Note :- (8) For online examination, rechecking and revaluation are not allowed but print out of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the ranked list to be published for this post.
