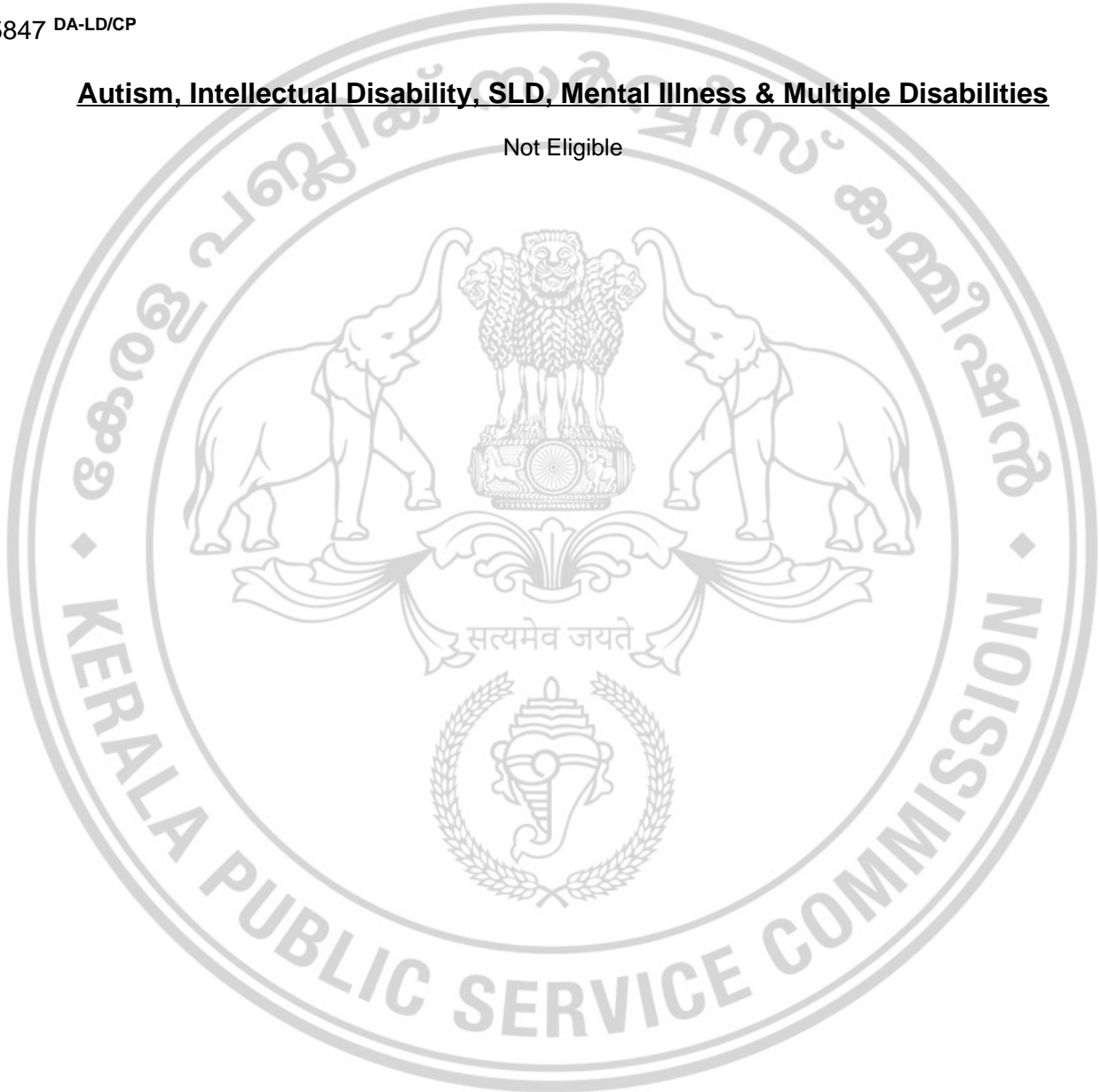

Note:- (2) The probability list is prepared based on the details furnished by the candidates in their applications and subsequent claim made will not be entertained at any stage of the selection.

Note :- (3) 92 (Ninety Two) candidates who have secured top most marks in the Common OMR Examination held for the post on **26.04.2025** are included in the Main List of this Probability List. The Marks secured by the last candidate in the Main List is **62.33 (Sixty Two point Three Three)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes , Other Backward Classes and Economically Weaker Sections (and other reserved categories if any) necessary supplementary lists are prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) The register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Probability list without further notice.

Note:- (5) Candidates included in the Probability List should be present in person and produce the original documents for **One Time Verification. Date,time and Venue of OTR Verification will be intimated in due course through profile message and SMS.**

Note :- (6) Candidates belonging Other Backward Classes included in this list are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Tahsildar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate in the format prescribed vide G.O.(MS) No.2/2020/P&ARD dated 12.02.2020 issued by the Village Officer as proof of their claim, along with other relevant documents at the time of OTR verification.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the common OMR Test held on **26.04.2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after the publication of the Ranked List. No answer scripts are invalidated as per Notification **No: ER 2-1/5/2025-KPSC Dated 27.06.2025 of the Secretary,Kerala Public Service Commission.**

Note :- (9) "Inclusion of GNM/BSc Nursing qualified candidates in the list and any appointment made shall be subject to the result of OP(KAT)253/2021 & SLP(C) No.13242/2021".
