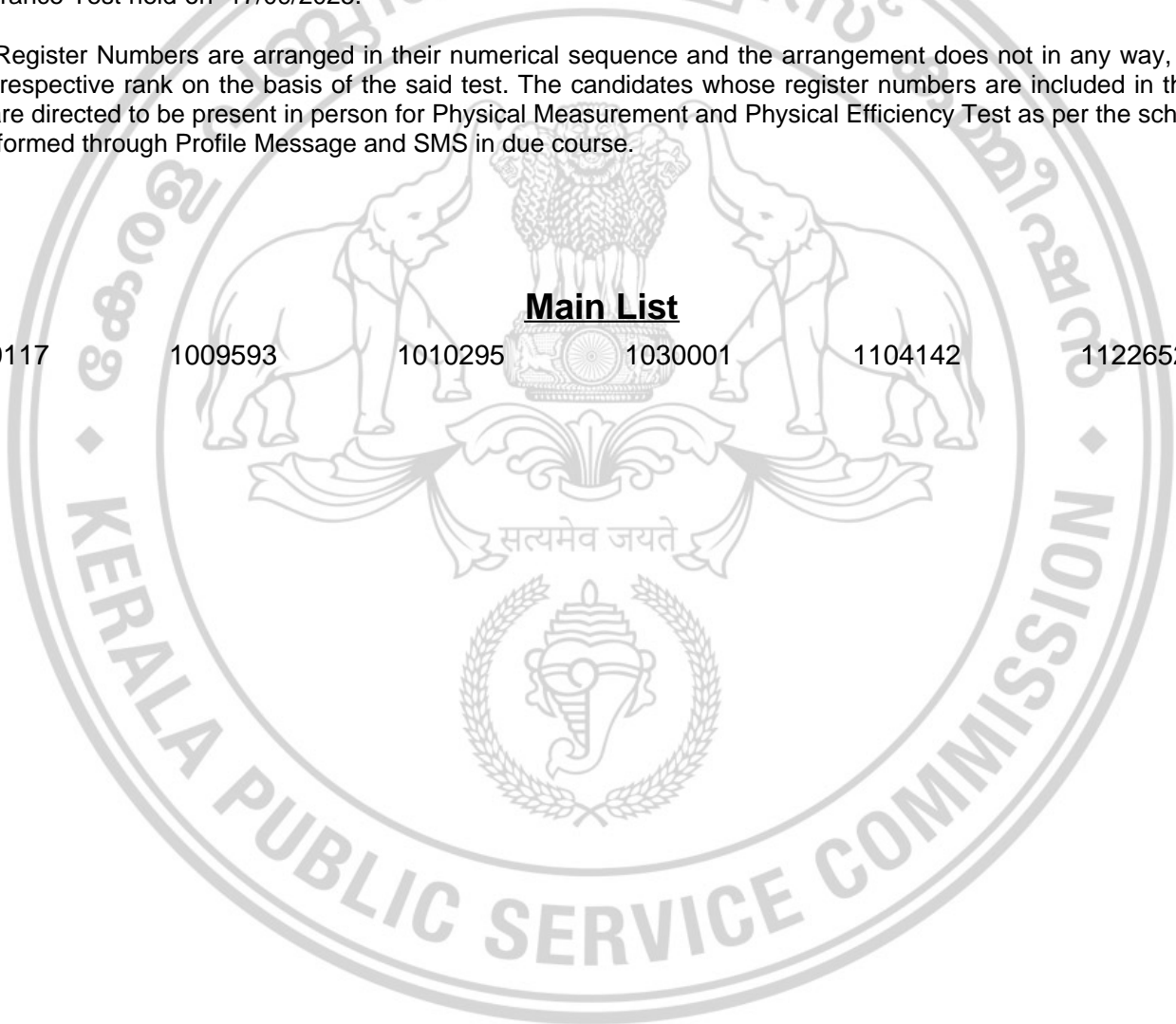

Note:- (4) The Physical Measurements of candidates will be taken prior to the Physical Efficiency Test and those who do not possess the prescribed physical measurement will not be admitted for the Physical Efficiency test. If accidents or injuries happen to a candidate while participating in the Physical Efficiency Test, he will not be given further chance to participate in the test.

Note :- (5) Candidates included in the Short List , eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SCSTDD dated 26.09.2009 issued by the competent Revenue Authority in proof of their claim along with other relevent documents at the time of OTR verification.
