Note :- (3) Candidate included in the Short List should present and produce in person the original documents for One Time Verification and Interview. Date, time and Venue of OTR Verification and Interview will be intimated through Profile message and SMS indue course.

Note :- (4) The Register number of those candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (5) Candidates belonging Other Backward Classes included in this Short list are required to produce Non Creamy Layer Certificate as per G.O.(P) No.81/2009/SC/STDD dated 26.09.2009, candidates belonging to SC/ST are required to produce Community Certificate in Form III or Digitally Signed issued by the Revenue Authority not below the rank of Thahilsdar and candidates belonging to Economically Weaker Section are required to produce EWS Certificate vide G.O(MS) No.2/2020 P&ARD dated 12.02.2020 issued by the concerned authority.

Note :- (6) For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
