For the purpose of satisfying rules of reselection of appointments to Scheduled Castes, Scheduled Tribes, Other Backward Classes and EWS, necessary supplementary lists are prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. Date, time and Venue of OTR Verification will be informed through profile Message and SMS.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate as per GO(P) No.81/09/SCSTDD dated 28.06.2009 or that obtained through e-district portal in the format prescribed in GO(Rt) No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority and candidates who claim EWS reservation are required to produce EWS certificate vide GO(MS) No. 3/2024/P&ARD dated 25.04.2024 along with other documents mentioned, at the time of OTR verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **04-08-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
