Note :- (4) Candidates included in the Probability should be present in person and produce the original documents for One Time Verification. Date,time and Venue of OTR Verification will be intimated in due course through profile Message and SMS.

Note :- (5) The register number of those candidates who do not produce the required documents with the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice.

Note:- (6) At the time of One Time Verification, SC/ST Candidates included in the Probability List are required to produce Community Certificate (Form III or Digitally Signed) issued by competent Revenue Authority not below the Rank of Tahsildar, candidates belonging to Other Backward Classes are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O (P) No.81/2009/SC/STDD dated 26.09.2009 and Candidates claiming reservation under EWS Category are required to produce Income and Asset Certificate issued by the Village Officer as per G.O.(Ms) No. 2/2020/P&ARD dated 12.02.2020 along with other documents.

Note :- (7) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (8) Copy of answer scripts of the OMR Test held on 11-07-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answerscript is invalidated as per Notification No : ER VIII- 2/6/2025-KPSC Dated 3.11.2025
