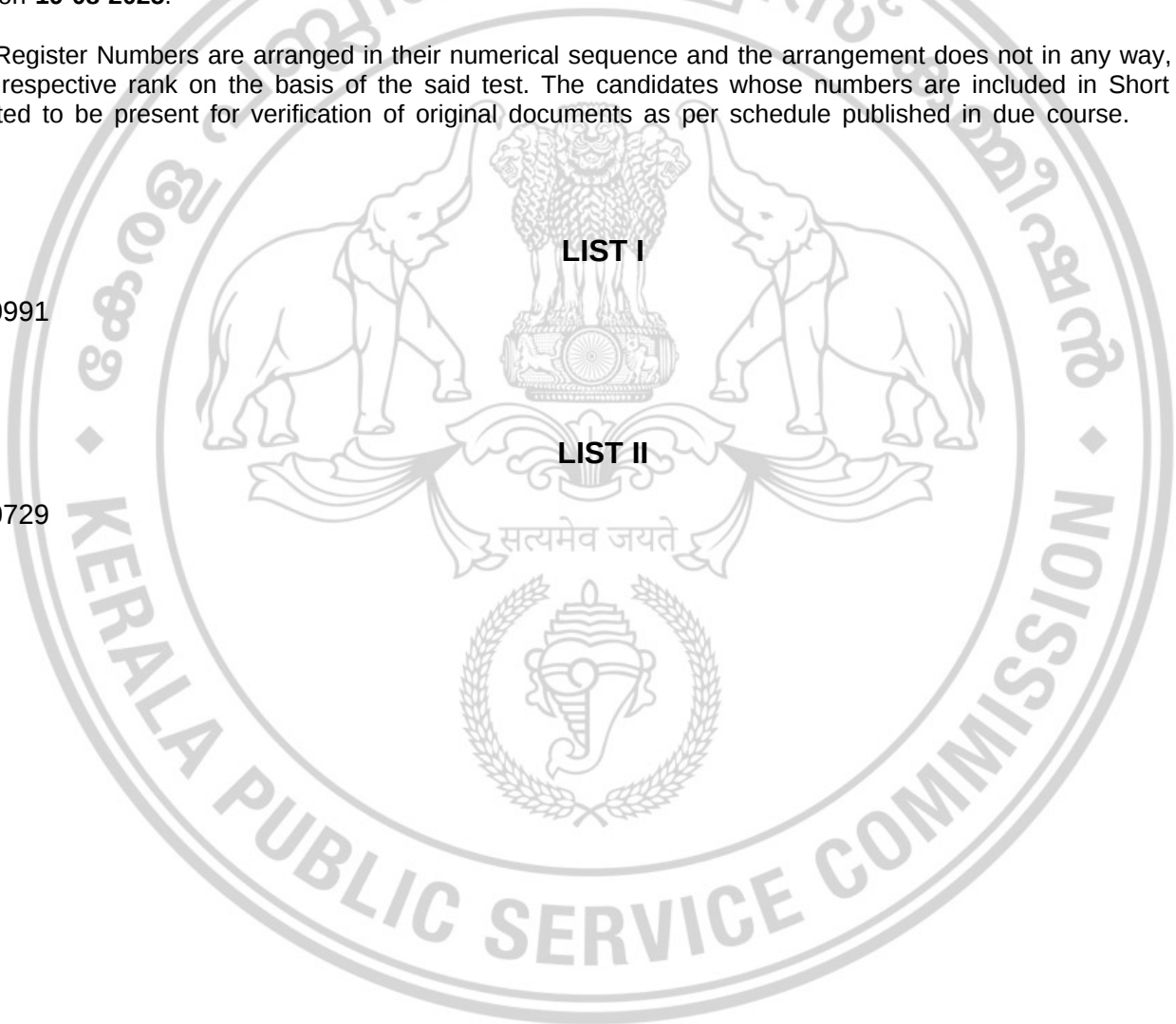

Note :- (6) Candidates included in the Short List are required to produce Community Certificate issued by the Revenue authority along with other relevant documents at the time of OTR Verification.

Note :- (7) The Register number of candidates those who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the short list without further notice.

Note :- (8) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.
