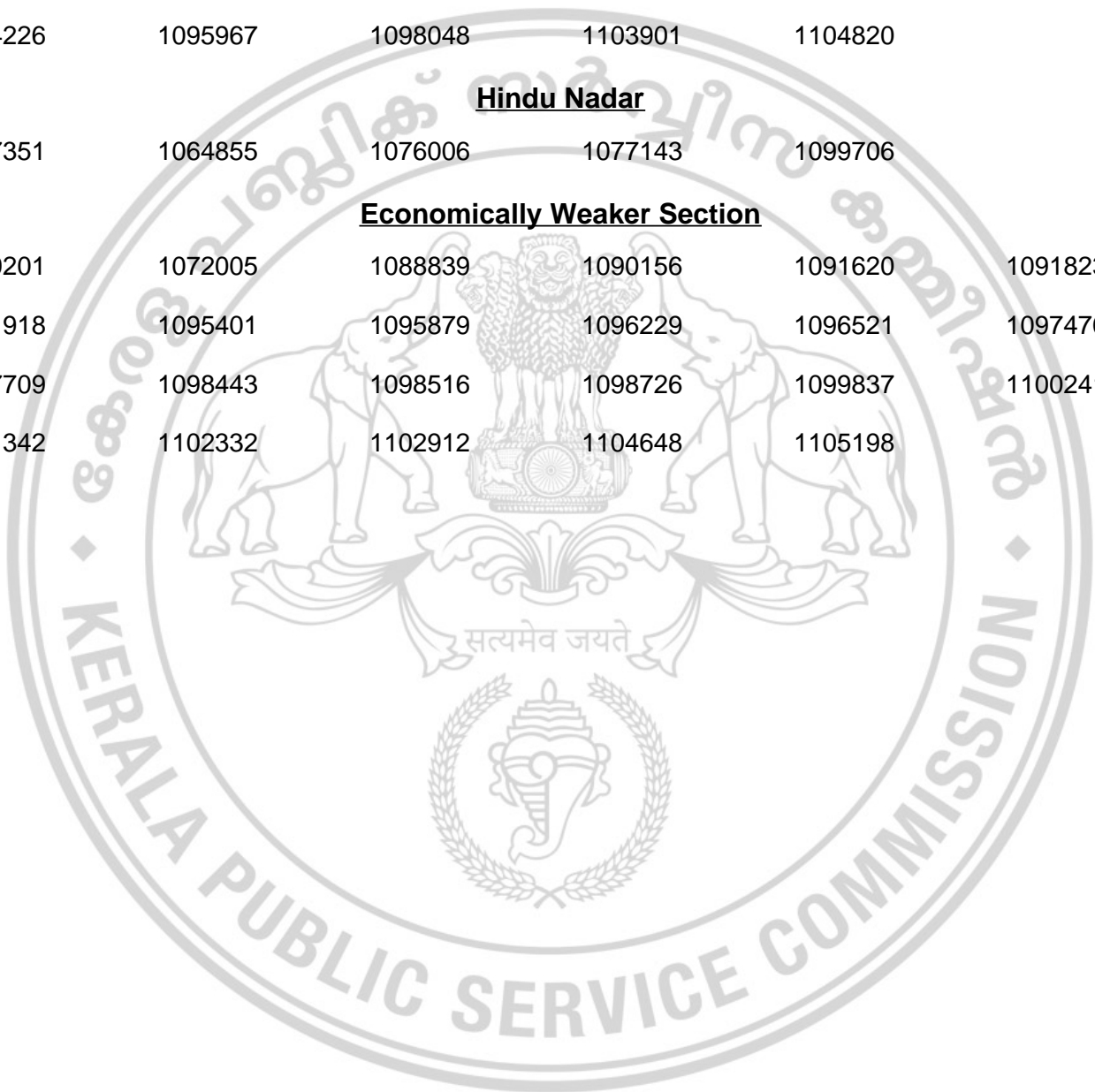

Note :- (3) **132 (One Hundred And Thirty Two)** candidates who have secured top most marks in the OMR examination are included in the Main List of the Probability List. The Marks secured by the last candidate in the Main List of the Probability List is **64.67 (sixty four (point) six seven)** . For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes and Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of OTR Verification will be published shortly.**

Note:- (5) The Register number of candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the Probability List without further notice

Note :- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post

Note :- (7) Candidates included in the Probability List belonging to Other Backward Classes are required to produce Non-Creamy Layer Certificate issued by the Village Officer as per G.O. (P) No. 81/09/SCSTDD dated 26.09.2009. SC/ST candidates are required to produce Community Certificate either in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar and Candidates belonging to Economically Weaker Section are required to produce Income and Asset Certificate issued by the Village Officer in the format prescribed vide G.O (MS) No. 2/2020/P&ARD dated 12.02.2020 as proof of their claim, along with other relevant documents at the time of One Time Verification.

Note:- (8) Copy of answer scripts of the OMR Test held on 02-08-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated for this post are advised to refer Notification No:ER 2-3/11/2025-KPSC DATED 30.10.2025 of Secretary KPSC.
