Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List should present and produce in person the original documents for **OneTime Verification. Date, time and Venue of OTR Verification will be intimated through Profile message & SMS in due course.**

Note :- (7) Candidates belonging to Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated 26.09.2009. SC/ST candidates are required to produce a Community Certificate in Form III or digitally signed certificate issued by the Revenue Authority not below the rank of Tahsildar & EWS Certificate as per G.O.(MS) No.2/2020/P&ARD dated 12/02/2020 issued by the Revenue Authority in case of candidates having EWS reservation at the time of OTR Verification.

Note :- (8) The Register Number of those candidates who do not produce the required documents within the prescribed time and those applications found otherwise defective will be deleted from the Short List without further notice.

Note :- (9) Copy of answer scripts of the OMR Test held on 20-08-2025 will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated. No candidates are invalidated for this post as per Invalidation Notification No : ER 7-3/3/2025-KPSC dated 31.10.2025
