Note 2:- The candidates who have secured **22.33 (twenty two (point) three three)** Marks and above in the OMR Test held on 22.10.2025 are included in the eligibility list. The minimum marks for inclusion in the list of candidates belonging to various reservation communities have been lowered to ensure their adequate representation in the eligibility list. Candidates whose inclusion is due to the benefit of reservation to ensure adequate representation, shall have to prove their claim by producing Community Certificate/ Non Creamy Layer Certificate / EWS Certificate at the time of One Time Registration Verification, if they are included in the list to be published after the Dictation Test. Note 3:- The marks secured in the Common OMR Examination by the candidate will be considered only for ascertaining the eligibility to appear for DICTATION TEST and will not be considered for the purpose of final ranking and shall not have any relevance while preparing the Rank List for the post. .

Note 4:- If any of the documents produced by any candidate is found defective the Commission reserves the right for rejection of their candidature at any stage of selection as per rule.

Note 5:- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for through their one time registration profile from the Commission's Official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five Only). The fee can be remitted by e-payment through the portal. Applications submitted in any other manner (ie, via E-Mail/Tappal/Direct) will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of answer scripts will be allowed to candidates with effect from the date on which the eligibility list is uploaded in the website of the commission. The candidates can avail only one chance for rechecking after the Approval of Eligibility List within the time limit fixed above. Rechecking of answer scripts invalidated due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.
