The candidates are required to produce latest extract of Driving Licence at the time of OTR verification. Candidates called for the Practical Test will have to produce Medical Certificate for physical fitness in the prescribed form from the Medical Officer not below the rank of an Assistant Surgeon in Govt. service and a Medical Certificate from an Ophthalmologist in Govt service. Form of Medical Certificates are available in the Notification.

Note :- (2) This list has been prepared by including those candidates who are qualified in the Physical Measurement & Physical Efficiency Test and based on the details furnished by the candidates in their Application and subsequent claims made will not be entertained at any stage.

Note :- (3) The candidates included in the Short List should be present in person for Practical Test (Driving Skill Test) . **Date, Time and Venue of the Practical Test** will be intimated through Profile Message and SMS in due course. The short listed candidates should download their Admission Tickets from their OTR profiles logging on to the Official Website www.keralapsc.gov.in of Kerala Public Service Commission and appear for the test with necessary documents.

Note :- (4) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.

Note :- (5) Candidates included in the Short List are required to produce Non Creamy Layer Certificate issued by the Competent Revenue authority vide GO(P) NO. 81/09/SCSTD Dated 26/09/2009 at the time of One Time Registration Verification.

Note :- (6) Copy of answer scripts of the OMR Test held on **17-07-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
