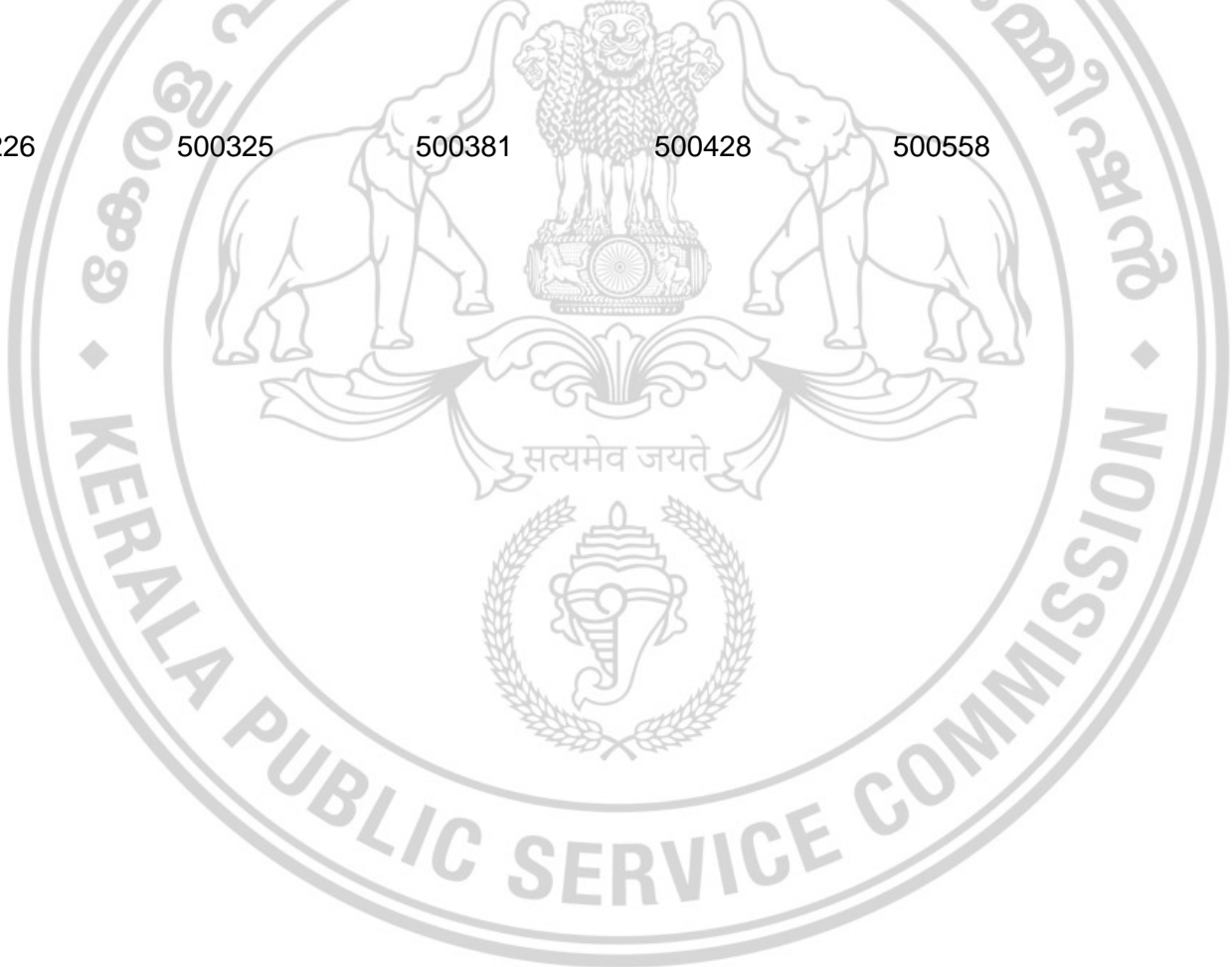

Note :- (8) Scanned Image and Tabulation sheet of answer scripts of the Descriptive Test held on 01/09/2025 & 02/09/2025 will be issued to only those candidates who had attended all the Three Papers and who apply for the same remitting the prescribed fee after the publication of the Ranked List.
