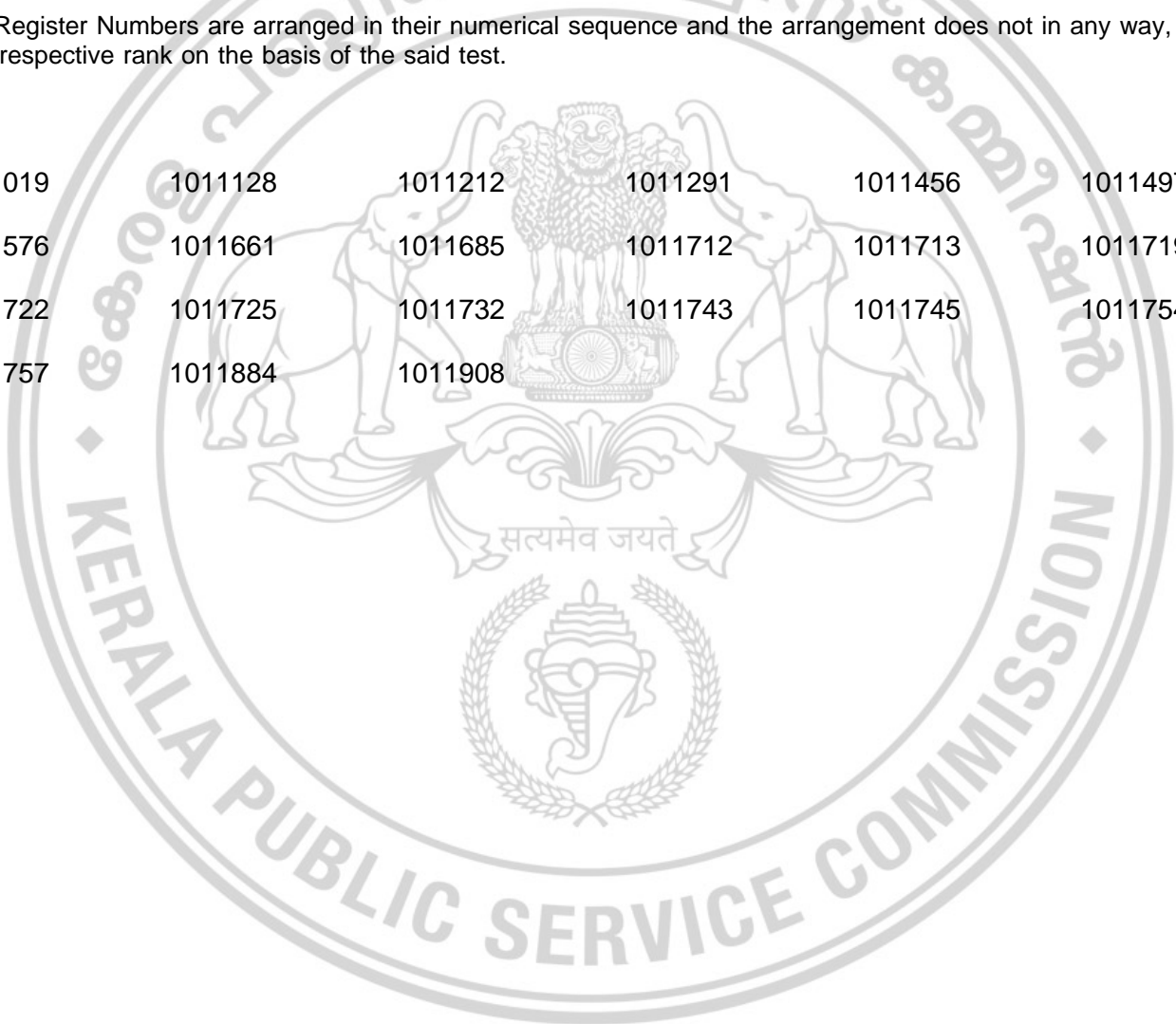

Note :- (6) Candidates belonging to the Other Backward Classes included in the Short List are required to produce a Non Creamy Layer Certificate as per G.O.(P) No. 81/2009/SCSTDD dated:26.09.2009 issued by Village Officer, SC/ST candidates are required to produce a Community Certificate either in Form III or digitally signed certificate issued by Revenue Authority not below the rank of Tahasildar and candidates who claim EWS reservation are required to produce Income and Asset Certificate vide GO(Ms) No. 02/2020/P&ARD Dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR verification.

Note :- (7) Copy of answer scripts of the Common OMR Test held on **17-11-2025** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No :ER16-3/1/2026-KPSC dated 19.01.2026. of Secretary,KPSC.
